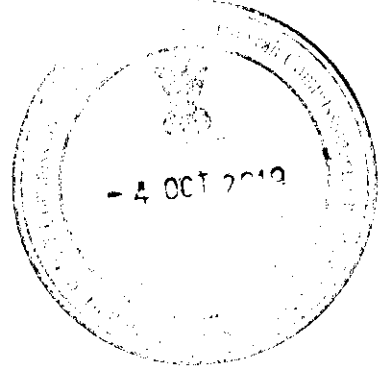

- 1) Copy of Circular Dated 03.05.2018, communicated under C.No. II(3)1-ET/Transfer & Policy/Pr.CCO/CGST & CX/Kol/2018/9569-584 Dated 03.05.2018 , as desired , is readily available and contains(05) pages.
- 2) As per point no. (II) of the Transfer and Policy-2018, the policy is applicable for all the Commissionerates of Kolkata GST Zone.
