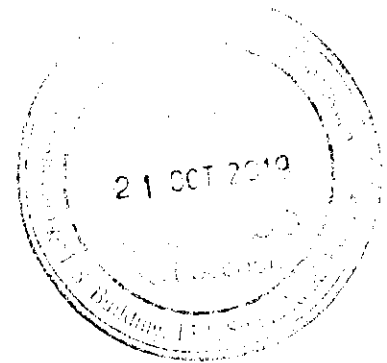

Sub: - RTI application filed by Shri Pradeep J. Talekar, under RTI Act, 2005- Furnishing of information & Request for sending fees for supply of documents under the RTI Act -reg.

Please refer to your RTI application dated 16.10.2019 received by this office on 21.10.2019 filed directly and subsequently been registered under Registration No. 69/RTI/CGST/HWH/PJT/2019-20.

The desired information as sought for in your above mentioned RTI application, in respect of Howrah CGST & CEX Commissionerate, as received from the Section concerned i.e. H.Q. ET, DPC & LAW Branch, Howrah CGST & CEX Commissionerate are mentioned point wise herein below :


1. The desired Establishment Order No. 62/2010 dated 20.09.2010 issued by Shri J.P. Singh, Jt. Commissioner (P&V), CEX, Kol-II Comm'te, vide F.No. II(3)9-ET/MACP/Kol-II/2010/10161-10348A dated 20.09.2019 contains in the form of **11(Legal) pages**.
2. The information sought for against this point is mentioned in the above said order.
3. This information is contained in Estt. Order No. 20/2015 dated 26.02.2015 vide C.No. II(3)10-ET/MACP/Kol-II/2011/1477-1505A dated 26.02.2015 numbering **17 pages**.
4. So far this point is concerned, this is for your information that an Office Memorandum has been issued through C.No.II(3)1-DPC/Kol-II/2009/10141A dated 17.09.2010 by the then Joint Commissioner (P&V) erstwhile Central Excise, Kolkata-II Commissionerate. The Office Memorandum contains **18 (Legal) pages**.
5. As regards this point, it appears from the office records that WPCT No.3 & 4 of 2019 arising out of O.A. No.350/651 of 2015 in the matter of Ranjit Kumar Biswas and Ors. Vs U.O.I filed by applicants being aggrieved due to withdrawal of MACP benefits granted earlier vide Estt. Order No.62/2010 dated 20/09/2010.

However, the copy(s) of the documents so sought for by you in your above mentioned RTI application cannot be provided since the same is sub-judice before the Hon'ble High Court. Over and above, the impugned information is exempted under the provisions of Section 8(1)(j) of the RTI Act 2015 inasmuch as the same have no relationship to any Public activity or interest and would cause unwarranted invasion of privacy.

In this regard, it is to be stated that in order to supply the copies of desired documents, the requisite fees for an amount of Rs.22/- (Rs.2/- per page x 46/-) is required to be paid in the form of IPO/DD/Banker's Cheque/Cash payable to the Assistant Chief Accounts Officer of Howrah CGST & CEX. Commissionerate, Kolkata in terms of Section 7(3) (a) of RTI Act, 2005. However, since you have already furnished an IPO for Rs.50/- you are requested to send the residual fees of Rs.52/- (Rs.92.00 - Rs.40.00) for supply of the desired documents.

If you are aggrieved with the reply, you are at liberty to prefer First Appeal within the stipulated time i.e. 30 (thirty) days from the date of receipt of this reply before **Shri Pradeep Kumar Bohra**, Additional Commissioner & Appellate Authority under RTI Act, 2005, Central Tax, Howrah GST Commissionerate, M.S. Building (1st floor), 15/1 Strand Road, Kolkata - 700 001.
