

The desired information as sought for in your above mentioned RTI application, in respect of Headquarter, Howrah CGST & CEX Commissionerate, as received from the section concerned i.e. H.Q. Accounts Branch, Howrah CGST & CEX Commissionerate are as under:

This is for your information that Shri Nripendra Lal Ghosh, Son of Late Amrit Lal Ghosh, retired from Govt. Service as an Assistant Collector not as a Collector as mentioned in your impugned RTI application.

However, this is for your information that the desired information as contained at **Point Nos. I, IV, VII & VIII** of RTI application, it is worth citing that the same do not qualify to serve any larger public interest, hence the same are exempted from disclosure in terms of Rule 8 (1) (j) of the Right to Information Act 2005. Over and above, in terms of Rule 257 (2) of General Finance Rule, 2005, it is decided that "the service book of a government servant shall be maintained in duplicate, First copy shall be retained and maintained by the Head of the Office and the second copy should be given to the government servant for safe custody "as indicated below:-

- (a) **To the existing employees** – within six months of the date on which these rules become effective.
- (b) **To new appointees** – within one month of the date of appointment. Hence, it appears that there is no scope to provide Xerox copy of Service Book to you.

However, the information sought for as at point no. II, III, V and VI are furnished herein below:-

Point Nos. II & III: Regarding these points this is to state that information's are not available with this Commissionerate.

Point No.V: The date of joining in Service of Late Nripendra Lal Ghosh, Ex-Assistant Collector was/ is on 01.03.1944.

Point No. VI: The date of Retirement of Late Nripendra Lal Ghosh, Ex-Assistant Collector was on 31.12.1985.
