This list was not in accordance to any seniority List of Inspectors or zone of consideration for promotion as the issue of seniority of Inspectors of this zone is subjudiced and disputed at present.

Point No.4, 5& 6: No information is available at this Commissionerate.

Point No.7: It is to intimate that the Inspectors who were posted in the Commissionerates situated in Kolkata (as per available records) have been nominated for the training at random.

Point No.8: Yes.

Point No.9: This is to inform that representations have been received against draft seniority list dated 28.03.2015, which were duly considered at the time of issuance of the final seniority list of 30.11.2015. Representations after final seniority list of 30.11.2015 have also been received. No speaking order has been issued disposing of such representations.
