Subject: RTI application under Section 6(1) of the RTI Act, 2005- case of Sri Narottam Pandey.

It has been noticed that for conducting the Mandatory Training for promotion to the grade of Superintendent, a list of 128 officers of Kolkata Zone has been nominated and published vide C.No.II(36)4-ET/HWH-GST/Trg-NACIN/2018 dated 04.12.2018. It is pertinent to mention herein that for promotion, preparation of Zone of consideration as per RR and DPC Rules is mandatory where Seniority List in the feeder grade shall be the key. It remains undisputed that in terms of Hon'ble High Court, Calcutta's Order dated 24.07.2018 in WPCT No.47 of 2018 promotion to the grade of Superintendent cannot be made on the basis of 2015 Seniority List of Inspectors till disposal of the O.A. No.604 of 2017 which is subjudice before Hon'ble CAT, Kolkata Bench and is adjourned sine die till disposal of WPCT No.81 of 2014, whereas by virtue of stay Order granted in WPCT 81 of 2014, 2010 Seniority List has been in force.

In this connection, the following information is sought for under Section 6(1) of the RTI Act, 2005 :-

**Information Sought For**

Name the Seniority List of Inspectors that has been taken into account for nomination of Inspectors for imparting the Mandatory Training scheduled to be conducted from 05.12.2019 to 16.12.2019, be it 2010 Seniority List or 2015 Seniority List.

Considering the urgency of the matter having the ingredients for invoking the time limit, it is requested to provide/supply the information within 48 hours or within normal period of seven days, at the latest, as per provisions under Section 7 of the RTI Act, 2005.
