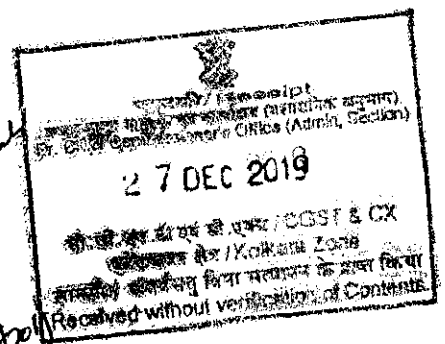

Sub:- Request to furnish information under Section 6(1) of the right to information Act, 2005 on the following question/ points.

Being a citizen of India it is requested to furnish the following information/documents in terms of Section 6 of the Right to information Act, 2005:-

1. In para 6 of Office Memorandum dated 31.03.2010 regarding draft seniority list as on 01.01.2010, it is mentioned that any representation in this regard from the incumbent received direct "without through proper channel" shall not be entertained under any circumstances. In this regard please provide information as to whether the draft seniority list as on 01.01.2010 has been finalized after considering all the received representation. If, yes please provide the copy of the same along with copy of relevant pages of note sheet.
2. Please provide information as to whether any letter has been issued in 2019 from CBIC, Department of Revenue, Ministry of Finance, Govt. of India with direction to maintain status quo on the seniority issued. If, yes please provide the copy/copies of the same.
3. Please provide information regarding steps taken by the Department (CGST & CX, Kolkata Zone) in order to vacate the stay order dated 24.07.2018 issued by Hon'ble Calcutta High Court in WPCT 47/2018 till date to start the promotion to the grade of superintendent for smooth functioning of the office work of the department.
4. Please provide information of the grounds on the basis of which 'Mandatory Training for promotion to the grade of Superintendent has been imparted to the inspectors who joined upto 2007 vide the letter under C. No. II(36)4-ET/HWH-GST/Trg-NACIN/2018/8322-B dated 13.12.2019. Please also provide the copy of the relevant pages of not sheet.

If any information not available in your office, kindly forward the same to the concerned public authority as per section 6(3) of the RTI Act, 2005.
