

Para 5.3.2 of Chapter No. 5 'Reservations in Services for SCs/STs/OBCs' of the Handbook for Personnel Officers dated May' 2018 of DoPT which is being produced as following – "However, reservation in promotion is not given in the grades in which the element of direct recruitment, if any, exceeds 75 percent"
2. OM No. 36012/17/88-Estt.(SCT) dated 25th April, 1989 which states thatas indicated above should be made applicable to all grades services in which the element of direct recruitment, if any, does not exceed 75%.
3. The desired information as sought for in your above mentioned RTI application, in respect of Howrah CGST & CEX Commissionerate, as received from the Section concerned i.e. H.Q. ET & DPC Branches, Howrah CGST & CEX Commissionerate are mentioned point wise herein below :

Point No.1:- In this regard this is to state that the guidelines contained in OM 36012/17/88-Estt.(SCT) dated 25.04.1989, is followed in promotion to the grade of Inspector, since the new recruitment Rules, 2016 has been notified on 26.12.2016.

Point No 2: So far this point is concerned, this is for your information that the Roster for promotion quota in the grade of Inspector of this zone was recast from 1997 while implementing DoPT OM No. 36012/45/2005-Estt.(Res) dated 10.08.2010 and maintained electronically in this Commissionerate for the vacancies arisen till 25.12.2016, before the new recruitment rules, 2016 is notified. Roster was again recast on 2018 applying DoPT OM No.36012/2016-Estt.(Res) dated 30.09.2016 while a DPC was fixed for regularization the adhoc Inspector. Copies of rosters maintained electronically for the years 2013-14, 2014-15, 2015-16 and upto 25.12.2016 in both types mentioned above are **contains in the form of 114(One hundred fourteen) legal Sheets**. After 26.12.2016 this office has discontinued the maintenance of roster register for promotion to the grade of Inspector.






