



The desired information as sought for in your above mentioned RTI application, in respect of Howrah CGST & CEX Commissionerate, as received from the Section concerned i.e. H.Q. ET, DPC & Law Branches, Howrah CGST & CEX Commissionerate are mentioned point wise herein below :

Point No.1:- Regarding the sought for information at this point, it is to inform that the outcome of the review DPC was not published. The reasons for not publishing the outcome of the review DPC held on 03.01.2013 have been mentioned at Para-04, 05, 06, 09, 10, 11, 12, 13 and 14 of the speaking order issued by the Principal Chief Commissioner, CGST and Central Excise Kolkata Zone vide C. No. I(10)8-DPC/Howrah/S.Mandal/2019/5991-6003 B dated 01.10.2019.

Point No 2: So far this point is concerned, this is for your information that at present Howrah Commissionerate is not maintaining the reservation roster in promotee quota of Inspector as per DoPT OM No. 36012/17/88-Estt.(SCT) dated 25.04.1989 which **contains 01(one) page**.

However, SC/ST reservation roster in respect of Inspector (Direct Recruitment) is maintained and **contains 40(Forty pgs)**.

Point No.3& 4: The information sought for does not fall within the ambit of definition of "Information" as per Section 2(f) of RTI Act, 2005 read with DoPT OM No.11/02/2008-IR dated 10.07.2008.

In this regard, it is to be intimated that in order to supply the copies of desired documents, you are requested to send fees for an amount of **Rs.82.00/-(Rs.2 per page x 41pages)** in the form of IPO/DD/Banker's Cheque/Cash payable to the Assistant Chief Accounts Officer of Howrah CGST & CEX. Commissionerate, Kolkata in terms of Section 7(3) (a) of RTI Act, 2005
