Pentible Star Subject Application filed under Section 6(1) of the R.T.I. Act. 2005.

It is a matter of facts and records that the Seniority List of Inspectors published on 30° November, 2015, applying N.R. Parmar Judgment and unsettling settled seniority as fixed in the Seniority List dated 21.02.2008 and 31° March. 2010, whereby the junior direct recruits of 2005 and subsequent years have been made senior to 2003 batch of promotes. The said seniority list dated 30° November, 2015 has been made subject to final outcome of the W.P.C.T. No. 81 of 2014 (U.O.I. & Ors. Vs. Shiri Devesh Sankar Srivastava & Ors.) who is one of the junior direct recruits and hence one of the beneficiaries in the redrawn seniority list dated 30° November, 2015 which has been published of 2014 against the order of the Ld. Central Administrative Tribunal, Kolkata Bench for recasting seniority list in respect of the seniority list dated 31st March. 2010 is still alive.

Thereafter, the Board has issued clarificatory letter on 02.12.2016 for implementation of N.R. Farnar dudgment with prospective applicability, i.e. after 27th November, 2012. The then Chief Commissioner formed several committees—first, headed by the Cadre Controlling Commissioner and higher-level officers for implementation of N.R. Parmar Judgment in the light of Board's letter dated 02.12.2016 (subsequently confirmed under Board's letter dated 23.02.2018 and 31th August, 2018), where it has been decided that the N.R. Parmar judgment shall be prospectively applicable.

Ali of a sudden, status of high-power committee has been down-graded by comprising of the junior grade officers and staff having no jurisdiction, authority and power over cadre control and the said Shin Devesh Sankar Srivastava who is the main private respondent in the W.P.O.T. No. 81 of 2018 (and having already been benefited by promotion to the grade of Superintendent and having no been posted in the Commissionerate of Customs (Preventive), West Bengal, Kolkata and having no role in the administrative matter even in its remotest proximity) was inducted in the said committee that derailed the earlier decision on prospective implementation of N.R. Parmar Judgment His deliberation to espouse his own cause is evident from the minutes of the meeting held or; September, 2017 [Annexure-6 to the reply of the respondent in the matter of O.A. No. 356/268 of 2018 (Shri Avijit Das and Ors. Vs. U.O.I. & Ors.)]
