

In this context, it is worth mentioning that since the information sought for by the applicant firstly, the particulars of Order / Circulation / Notification etc., by which the Shed Appraiser was made equivalent to the post of Superintendent (Cargo) during the period May 2002 to May 2003 **against Point no.1** and secondly, the information i.e whether sale proceeds have been received against all the Bills of export through quoting four references of Vigilance Branch **against Point no.2** of the impugned application, the Establishment Branch & the Vigilance Wing respectively of this Commissionerate were approached/requested to furnish the requisite information as sought for by the applicant.


