2.	As per this Cadre Controlling Commissionerate, Total Sanctioned Strenght of EA in this zone is 434. Out of which, 174 posts are for Direct recruitment and 260 posts are for promotee quota.
3.	At the time of implementation of RR of Executive Assistant, there were 146 vacancies in DOS grade, and 13 vacancies in STA grade.
4.	Details of promotion conducted in the grade of STA & EA in this zone after cadre restructuring 2013:- (i) Promotion to STA : DPC held on 21.04.2015, as per RR of STA, 2003. (ii) Promotion to erstwhile STA (now EA) : DPC held on 23.06.2017, as per RR of STA, 2003; and letter issued by the Board vide F.No. A-32011/03/2015-Ad.III.A. dated 01.05.2017.
