Dear Sir,

I, Anam Kumar Das, a citizen of India, do hereby request the following information category under the RTI Act, 2005 along with the **certified legible copy** of the report/minutes issued with the **Office Order No. 61** date **18.03.2019** issued from the office of the Chief Commissioner, CGST & CX, Kolkata Zone, which reads as follows: "The office of CGST & CX, Kolkata Zone has directed that all the concerned offices of the CGST & CX, Kolkata Zone will be remain open on all Saturdays & Sunday of this month for the Revenue Augmentation Drive of this Zone. All the concerned offices shall remain open on the above mentioned days"

1. **Full Name** (not in abbreviated form) of the Principal Chief Commissioner, CGST & CX, Kolkata Zone, who passed the quoted direction.
2. The **authority of Law**, i.e. any Notification/Order issued by CBIC/DOPT/GOI in this regard to keep the "concerned offices" open on all Saturday & Sunday of this month for the ensuing Revenue Augmentation Drive prior to the date of the quoted direction passed, by virtue of which the said Principal Chief Commissioner acted accordingly.

Please supply the **certified legible copy** of such Notification/Order issued by CBIC/DOPT/GOI.

The first statement of the said **Office Order No. 61** dated **18.03.2019** confirms that the direction was passed by the Principal Chief Commissioner, CGST & CX, Kolkata Zone, but the second statement – “*All the concerned officers are directed to attend the offices on the above mentioned days.*” instils an ambiguity about the direction.

Please inform the **Full Name** and **Designation** of the particular **Officer** who has directed “*All the concerned officers*” “*to attend the offices on the above mentioned days*” specifying the **legal authority/provision** in support of passing the said direction.

4. The **Full Name** and **Designation** of the particular **Officer** who initiated the file noting with a view to direct “*All the concerned officers*” “*to attend the offices on*” “*all Saturday & Sunday of this month*”.

Please supply the **certified legible copy** of the Note-sheet(s) reflecting the particular File No., date of initiation of the Note, the accurate and complete content of the Notes till it culminated to the final direction.

5. The **Full Name** and **Designation** of the particular **Officer** under whose direction, if any, the said file noting was initiated.

6. The second statement of the said **Office Order No. 61** dated **18.03.2019** states the words – “*concerned officers*” without clarifying the category of the officers, i.e., whether those “*concerned officers*” as are defined under Section 3 of GST Act 2017 read with Section 2(b) of Central Excise Act 1944.

Please state the particular category of officers who falls within the ambit of “*concerned officers*” and under which provision of Law.

7. Please specify the **starting date** of “*ensuing Revenue Augmentation Drive of this Zone*” and the **end date** of the purported “*Drive*” and the period in total it covers.
8. Please specify the **factors** of the said “*Drive*” that will augment “*Revenue*” “*of this Zone*”

“*All the concerned officers*” “*on all Saturday & Sunday of this month*” at “*all*”

copy of the said **Office Order No. 61** dated **18.03.2019** was endorsed to the "**staff** of the *Principal Chief Commissioner's Office, CGST & CX, Kolkata Zone*" vide C. No. I(22)1-Admn/Misc/Pr. CCO/CGST & CX, Kolkata Zone/ 4688 – 701 dated 18.03.2019.

Please inform the **manner** the said "**staff**" could augment "*Revenue*" "*of this Zone*" so that they were endorsed a copy of the said Order.

10. The specific quantum of revenue that is **projected in writing**, while passing the quoted direction, to be generated through keeping "*the concerned offices under the CGST & CX, Kolkata Zone*" "*open on all Saturday & Sunday of this month*" and by attendance of the "*concerned officers*" which could not be achieved performing on the weekly working days.
