In this regard, the point wise reply is furnished below:-

1. Yes, GST is required to be paid on land owners' share of flats but at time of first occupancy or completion of the flats and the taxable value will be the consideration of similar flats.

2. In case ITC is availed, proportionate ITC is to be reversed.
