1. As per transfer & posting policy for ministerial officers (Group B&C), Senior Private Secretary, Private Secretary, Steno Grade-I and Steno Grade-II of CGST & CX. Kolkata Zone dated: 08/10/2020 issued from the Office of the Principal Chief Commissioner, Goods and Service-Tax & Central Excise, Kolkata Zone, GST Bhawan, the tenure for in the Less-HRA category posting areas for officers from CCA Category posting areas will be one and Half Years at one time, and no officer will be allowed for posting in the same commissionerate continuously for more than 06 years and the period of serving continuously in a particular commissionerate for any Ministerial Officer should be divided into two phases i.e. 3 years in the Headquarters, & 3 Years in Divisions. In pursuance of the above Policy, I may kindly be informed that:
