

Please refer to your letter under C.No. V(30)109/RTI/HQ/CGST & CX/Kol North/2020/19284 dt. 16.10.2020 on the captioned subject.

In terms of the definition of INFORMATION' under Section 2(f) of Right to Information Act, 2005 "means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, legbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force".

The petitioner's right extends only to seeking information as defined under section 2(f) either by pinpointing the file, document, paper or records, etc., or by mentioning the type of information as may be available with the specified public authority

Being a Central Government Organization, whatsoever decision has been taken by the authority was in strict conformity with the procedure laid down the statute read with NDMA 2005, there is bar on jurisdiction of courts (S 71) and there is no grievance redressal mechanism under DM Act. Having assumed the role of sentinel on the qui vive (State of Madras v. V G Row, 1952), it is obligatory on all the constitutional courts in the country to suo motu register PILs and closely monitor the implementation of DM Act, ensure rule of law and protection of human rights as guaranteed under the Constitution of India. Thus, the information as sought for by the applicant mentioned above does not fall under the category of INFORMATION in terms of Section 2(t) of Right to Information Act, 2005, thus cannot be provided.

If you are not satisfied with the information above you may preferred appeal before the ADC, CGST & CEx., Kolkara North Commissionerate within 30 (Thirty) days from the date of receipt of the communication.

This is for your information and necessary action please.
