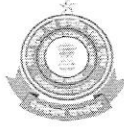

In this context, the point – wise reply in respect of the above mentioned RTI reply is furnished below. on the basis of the information / records available with / maintained by the Hdqrs. ET Branch, CGST & CX, Kolkata North Commissionerate, Kolkata - for necessary action at your end please:-

(1) **Point No. (1): How much vacancy for the post of Inspector in your Zone has been reported for the year 2021?**

The Kolkata North CGST & CX Commissionerate is not the Cadre Controlling in respect of recruitment to the post of Inspector (CGST). Hence, no information is available with the Hdqrs. ET Branch, CGST & CX, Kolkata North Commissionerate, Kolkata.

(2) **Point No. (2): How many post for Tax Assistant has been reported for the year 2021?**

The total requisition for Tax Assistant for the year 2021 was sent to Pr. CCO as 7 (since there was no vacancy in the UR, ST & OBC categories, after adjusting the 5 negative vacancies in the grade of SC and the total 12 DR vacancies in the grade of TA, the final requisition for TA was reported as: Gen = 0 = SC = ST = OBC; EWS = 7) – vide “Annexure –A” along with this office’s covering letter C.No.II(31)17-ET/CGST & CX/Kol North/2017/11952 dated 09.08.2021 addressed to the Additional Commissioner, Pr. CCO, CGST & CX, Kolkata Zone, Kolkata (**copies enclosed**).

(3) Has any backlog vacancy reported for year 2021?

No backlog vacancy is reported in the grade of Tax Assistant for the year 2021 by this office.
