Whether my prayer for waiver/annulment/set aside or exonerate charged framed against me & waiver of major penalty imposed in O.I.C vide C.No.II(8)/Vig/Haldia/2011/185 dated 19.02.2013 after observing present scenario. Sub:-Prayer for upgradation /expunge of Below bench mark/Adverse remarks ACR/APAR for the period of 2010-2011 and to give benefit from getting my long awaited/due promotion in the grade of Superintendent as per seniority list of the year 2010.

Kindly refer to the office letter vide C.No.V (30)05/RTI/HQ/CGST&CX/Kol-North/2020/2870 Dated 20.01.2020.

Most respectfully, I beg to invite your attention to the following facts for favour of your kind consideration:-

1. That I like to bring it on record that during the period 2010-2011 I was posted at Taratala-II Divn.Technical branch, Kolkata -VI Commissionerate and was holding charges works related to Technical Section etc, Sri Kshitish Chandra Barman, Supdt. of Central Excise, as my controlling/reporting officer and Sri Bhabatosh Goswami, D.C./Tara-II, C.EX.Kol-VI. was my reviewing officer.
2. During the month of December,2014,A Xerox copy of APAR pertaining to the period of 2010-2011 was given to me (By hand) where in it was recorded Adverse /Below bench mark having no official letter of communication, issue no and no initial of the officials or signature on the said Xerox copy of APAR pertaining to the period of 2010-2011 and also the relied upon documents were not supplied related to the said APAR.of the period 2010-2011 before during period and after the period along with not giving chance of inspection of the original copy of the said APAR of the period of 2010-2011.
3. That it is worthy to say that neither I received any communication from my the then reporting & reviewing Authority from my previous office i.e. Tara-II divn, C.EX.Kol-VI Commissionerate nor my present office i.e service tax*divn.Haldia Commissionerate, Kolkata regarding Adverse /Below bench mark recorded in the APAR for the period of 2010-2011.Sir I never violated rules and regulations and office decorum before and after of my total service periods and never violated CCS(CCA) conduct rules.
4. That Sir, I beg to submit that Sri Kshitish Chandra Barman,Supdt.of C.EX.my the then (Reporting Authority) Tara tala -II divn & Sri Bhabatosh Goswami, D.C./Tara-II, C.EX.Kol-VI.(Reviewing officer) never acted and did not take any initiative to pull me up of deficiencies in discharging my duties and responsibilities. It is indeed painful for me as a subordinate official as I am to say ,for reasons best known to him/them ,my the then Supdt.,Sri kshitish Chandra Barman had taken recourse of various misdeeds to harass me, to malign my position, to intimidate and threaten me acting in a motivated way to sack me and accordingly both the Reporting as well as the Reviewing Authority have blatantly violated/failed to comply with the Government's rule and regulations and procedures set out/laid down on the score instead of taking up the matter with the Competent Authority of the department. On

scrutiny of the above said Xerox copy of APAR for the period of 2010-2011, the allegation to the effect that I am negligent to my duty i.e. "The officer did not attend office regularly during the material period. He could not show his ability in any type of office duty as he was absent a long period during the material period for his illness". During the said period I was seriously ill and for which I had to be on medical leaves with constant life saving much needed treatment. Therefore, it may kindly be appreciated that in the instant case of absence from office (not at a stretch) has unfortunately been caused by my ill health, which was beyond my control and my condition was so alarming that restricted my movement and precisely I was confined to bed. More over it is stated that on scrutiny of the Xerox copy of APAR for the period 2010-2011 which was given to me, not officially, in the month of December, 2014 i.e. after more than three and half years. It is observed that the said APAR for the period 2010-2011 having no signature or initial of the staff of office, office stamp, no self appraisal/brief resume where it is recorded in APAR a brief statement of work handled/done by me during the said material period of 2010-2011, (only Blank page). It is proved from the abovesaid XEROX copy of APAR that both my the then Reporting Authority And Reviewing Authority fabricated the actual facts of truth and blamed false allegation against me. It is worthy to say that the said xerox copy of APAR during the period of 2010-2011 has/had given to me by hand after three and half years from the said recorded period of APAR, 2010-2011 and In the circumstances it is stated hereinabove, as there is not in iota of truth and denied by me in the prayer/representation on 16.12.2014. It is need not to say that both the Reporting and Reviewing Authority/officer were totally biased, unjust and unfair, while assessing my performance would be corroborated by fact that neither before nor after the material period 2010-2011 had/have my performance been assessed in the negative/so miserably.

5. That on being helpless/destitute of the above acts, moreover, accordingly as per rules I submitted a prayer/representation for upgradation/expunge the said APAR for the period of 2010-2011 on 16.12.2014 on the basis of Xerox copy of APAR. (Copy Enclosed).

6. That Sir, I beg to submit that during the month of February, 2015 lodged grievance through CPGRAMS bearing registration no. i) CBOEC/E/2015/00220 dtd. 04.02.2015, ii) CBOEC/E/2015/00261 dtd. 08.02.2015, iii) CBOEC/E/2015/00295 dtd. 11.02.2015 and vi) CBOEC/E/2015/00235 dated. 06.02.2015 regarding non/un communicated adverse remarks in APAR for the period of 2010-2011, my promotion and prey to expunge the said non/un communicated adverse remarks but I was advised to submit appeal for upgradation as per rule but it is stated that already as per rules I submitted a prayer/representation for upgradation/expunge the said APAR for the period of 2010-2011 on 16.12.2014 on the basis of Xerox copy of APAR. (Copy Enclosed)

7. That Sir, I beg to refer i) DOPT.No.22011/3/88-Estt.(D) dated 11.5.1990, ii) DOPT.No.22011/1/2006-Estt.(A) dated 28.3.2006 iii) DOPT.No.22011/1/2005—Estt.(A)(pt.ii) dated 14.5.2009, iv) DOPT.No.22011/1/2010—Estt.(A) dated.13.10.2010, v) No.51/5/72 Ests.(A) dated.20.5.1972 vi) F.No.C-30013/40/2017.Ad.IVA dated.27.10.2017 (Ministry of Finance) along with No.21011/10/2016-Estt.(A-II), F.No.21011/10/2016-Estt-(A-II) & No.21011/1/2010-Estt.A dated 13.10.2010 vii) File No.C-50/10/2017-Ad-II dated. 13.02.2017 alongwith No.21011/02/2009-Estt.(A) dated 16.02.2009 & time Schedule for preparation of Confidential Reports are enclosed for perusal as the said reference. (Copy enclosed) I like to refer the Judgement of the Hon'ble Supreme Court dated 12.5.2008 in the case of Dev

Dutta vs Union of India (Civil Appeal No.7631 of 2002). I beg to refer to instruction no. F.No. 28011/12/2009-EC/Per. Govt. of India, Ministry of Finance, Department of Revenue dtd. 07.3.2011 and F.No.C-30013/40/2017-Ad.IVA, Govt. of India, Ministry of Finance, Department of Revenue dated 27.10.2017 alongwith No.21011/10/2016 Estt.(A) (A-II) dated 13.10.2017 and DOPT.No.21011/1/2010-Estt.A dtd. 13.4.2010

8. That But unfortunately, the said prayer/representation was rejected by the Competent Authority vide C.No.II (9)6/vig/Haldia/2014/250 dated 06.04.2015.(this is the only official letter was communicated to me regarding the said APAR.)(Copy Enclosed).

May I be permitted to approach before your goodself i) whether the said APAR communicated to me after more than half and three years is legally sound or not .ii) whether it is purely an act of victimization or not.Sir, you will definitely agree with me that a free mind rest on a free body and if the mind is filled with anxiety and anguish, one cannot be concentrate in his day to day work. And it is very much true that an employee of the lower rank is not supposed to tell lies unless he is corrupt and actuated by promises for reward. Still then, even for sake of argument, but not admitting their version to be true, an employee for his initial offence or lapse should not be subjected to a severe punishment like promotion, financial hardship, anxiety, anguish and depression for a period of several years, but should be afforded an opportunity to rectify himself, even if the contention of the department be taken to be true. The aforesaid allegation has been leveled against me out of grudge although there is no basis or foundation on such allegation.

This is put up and brought to your kind notice for perusal, information and consideration.

In view of the foregoing facts and circumstances of the instant case and my submission before your goodself, I would fervently pray and request you to kindly consider my prayer for upgradation/expunge of Adverse remarks in the ACR/APAR for the period of 2010-2011 for the case of Sri Ashis Bala, Inspector.Sir, this is the part of leave rules. I hope, your goodself will be kin enough to consider my above said long due promotion in the grade of Superintendent with seniority as per seniority list of the year 2010 with all benefits on my part for which I shall be grateful for ever.

PRAYER

Under the circumstances, it is humble submission to you that due to the "Below bench Mark"grading for the period 2010-2011,I have been/am being deprived/benefit from getting my much covered/long awaited promotion in the grade of Superintendent, which cannot but me to inexplicable pain and agony for no fault on my part. In the light of the above backdrop, I would earnestly entreat before your gracious self to kindly upgrade/expunge the adverse remarks from my ACR/APAR for the period of 2010-2011 and thereby render me entitled to /eligible for enjoying my long due promotion in the grade of Superintendent and as per relevant rules on granting my abovesaid prayer and with all consequential benefit on my part.

And I pray for your kind intervention in the case /matter as aforesaid for the interest of a subordinate Govt.employee as I am.

2. That I was posted at Raiganj P.U and holding charges of godown,arms,valuables,vehicles etc.Sri M.K.De ,Supdt of Customs as my Controlling Officer during the period 2003 to 13.7.2005 (until before Suspension from service on 14.07.2005.).**(Copy enclosed of Suspension letter dtd.14.07.2005).**
3. That During March 2005,Govt.money collected through T.R.5 on 09.03.2005 for Rs.1,45,000/- and on 20.03.2005 ,Rs.14,099/-and S.T. Rs.3,300/-were kept in the office almira with supervision of my the then Controlling Officer, Sri M.K.De ,Supdt of Customs, Raiganj Customs Preventive Unit, Raiganj, Uttar Dinajpur, W.B. and same could not be deposited **Immediately through TR-6 challan on account of various allotted day to day assignment, was within the knowledge of my then Controlling Officer, Sri M.K.De, Supdt. of Customs, Raiganj Customs Preventive Unit, Raiganj, Uttar Dinajpur, W.B. Accordingly a complained was lodged as F.I.R. to the police for prosecution case against me instead of taking up the matter with the Competent authority of the department on 15.07.2005.(Copy enclosed).** That a complaint letter was issued by the then Assistant Commissioner, Siliguri Customs Division, Siliguri. on 07.07.2005. Wherein number of 05(five) charges were framed against me regarding unlawful activities reported by the then Supdt.Raiganj P.U.(Sri M.K.De). **(copy of the letter of The Assistant Commissioner, Siliguri Customs Division, Siliguri. on 07.07.2005.
