

Sub: Review of Adhoc Appointment / Promotion

Sir / Madam,

It has been observed that some Officers / officials of the Department are found to be continuing on adhoc appointment / promotion for more than a year and drawing pay and allowances without prior permission from DoPT, which is not in order as per Para 6 of DoPT O.M. No. 28036/1/2012-Estt(D) dated 03.04.2013.

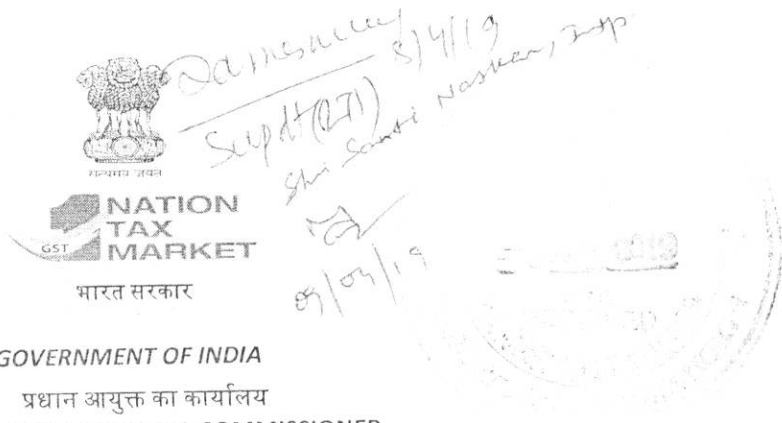
The rule stipulates that the total period for which the appointment/ promotion may be made, on an ad-hoc basis, by the respective Ministries/ Departments, is limited to one year only. These instructions further provide that in case of compulsions for extending any adhoc appointment/promotion beyond one year, the approval of the Department of Personnel and Training is to be sought at least two months in advance before the expiry of the one year period. Also, if the approval of the Department of Personnel & Training to the continuance of the ad-hoc arrangement beyond one year is not received before the expiry of the one year period, the ad-hoc appointment/promotion shall automatically cease on the expiry of the one year term.

In view of the above, all DDO / Competent Authority are requested to review the tenure of adhoc appointment / promotion of all concerned Officer / official of your Office as per DoPT O.M. dated 03.04.2013 and irregularities, if any, may be rectified at your end under intimation to this Office.

2.	As per this Cadre Controlling Commissionerate is concerned, there are ad-hoc promotee officers in the grade of Superintendent and EA (erstwhile STA). In Superintendent grade, the review of ad-hoc promotion could not be done due to Stay Order given by Hon'ble Calcutta High Court in the case of Narottam Pandey vs UOI & Ors., regarding seniority list of Inspectors. In EA grade, the process of regularisation of ad-hoc promotion was initiated, but could not be finalised due to letters issued by the Board on 04.01.2018 and 11.01.2018. The review was not done as the matter is still pending in Board and final decision is still awaited.
