In this context, the point-wise reply in respect of the aforesaid RTI application are furnished below, as per the office records available with the DPC Cell, CGST & CX, Kolkata North Commissionerate for necessary action at your end.

Point-A (1): The letter not received by this office.

(2 & 3): The MACP in the grade of Inspector was earlier done from Howrah Commissionerate. It was decentralised vide approval from Pr. CCO dated 11.02.2022. However, a letter under C.No. II (3)12-DPC/MACP/CGST & CX/Kol-North/2019/2045-67 dated 04.05.2022 requesting the MACP Proforma-A for all eligible officers in this commissionerate and directorates was circulated. MACP proforma-'A' in respect of the RTI applicant not received yet by this office.

Point C: Copy of Establishment Order dated 20.06.2022 issued for grant of financial up-gradation under the MACP Scheme post decentralisation is attached.


Point D: Date and time period i.r.of the Departmental Screening Committee is not mentioned.

Subject :- Grant of financial up-gradation under the MACP Scheme in respect of Group-A (except officers of the Organized Group-A Service), B and C Officers under purview of CGST & Central Excise, Kolkata North Commissionerate - regarding.

A Departmental Screening Committee (DSC) Meeting was held on 16.06.2022. The DSC referred to the DoPT's O.M. No. 35034/3/2008-Estt.(D) Dated 19th May, 2009 and subsequent clarifications/facts issued vide O.M. dated 16.11.2009, 09.09.2010, 01.04.2011, 13.06.2012, 04.10.2012, 10.12.2014, 18.02.2015, 28.09.2016, 04.07.2017 & DoPT's latest consolidated guidelines under O.M. No. 35034/3/2015-Estt.(D) dated 22.10.2019 and Board's (CBEC's) instruction dated 04.10.2017, for granting financial up-gradation under the Modified Assured Career Progression Scheme in respect of Group A (except officers of the Organized Group-A Service), B and C Officers under the purview of CGST & Central Excise, Kolkata North Commissionerate for the period ending upto September 2022.

Altogether, **119 (One Hundred and Nineteen)** cases were placed before the committee and all these cases were taken up for screening towards granting financial up-gradation under MACP Scheme.

The Committee considered the eligible officers for granting financial up-gradation under the MACP Scheme for the period ending upto September, 2022 in respect of Group A officers (except officers of the Organized Group-A Service), B and C Officers under purview of the Kolkata North Commissionerate on the basis of the information submitted.

The Additional / Joint / Assistant Commissioner (P&V), CGST & Central Excise, Kolkata North Commissionerate and Directorates have furnished the requisite Service Particulars, Vigilance Clearance, Integrity Certificate and APAR/ACR grading for five years of the Officers who were eligible to get 1st / 2nd / 3rd financial up-gradation under the MACP Scheme for the period ending September, 2022. As well as, this DSC has considered few cases of previous DSC dated 29.10.2021 in terms of DoPT's latest instruction regarding MACP dated 22.10.2019.

The under mentioned officers of CGST & Central Excise, Kolkata North Commissionerates and Directorates, are hereby granted 1st / 2nd / 3rd financial up-gradation under the MACP Scheme and placed in the corresponding Pay Matrix (Level) as per 7th CPC, with effect from the dates as shown against their name.

On the basis of the above, the Departmental Screening Committee recommends to grant 1st / 2nd / 3rd financial up-gradation under MACP scheme in respect of the following 9 Officers in the upgraded grade pay in the respective Pay Band / Pay Matrix (Level) with effect from the dates mentioned against their names.

The terms and conditions of this MACP order are as under :-


1. On grant of financial up-gradation under the Scheme, there shall be no change in designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government accommodation shall be permitted.
2. The MACPS contemplates merely placement on personal basis in the immediate Pay Matrix Level (higher Grade pay) / grant of financial benefits only and shall not amount to actual/functional promotion of the employees concerned.
3. Pay drawn in the Pay Matrix (Level, Cell) (pay band and the grade pay) allowed under the MACPS shall be taken as the basis for determining the terminal benefits in respect of the retiring employee.
4. The financial up-gradation envisages retention of old designation and does not confer any privileges relating to higher status.
5. The financial up-gradation under the MACP Scheme shall be purely personal to the employees concerned and shall have no relevance to his / their seniority position.
6. If, financial up-gradation has been allowed due to stagnation and the employees subsequently refuse the promotion, it shall not be a ground to withdraw the financial up-gradation. He shall, however, not be eligible to be considered for further financial up-gradation till he agrees to be considered for promotion again and the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal.
7. With regard to fixation of his pay on grant of financial up-gradation under MACP Scheme, a Government servant has an option under FR 22 (1) (a) (1) to get his pay fixed in the higher post / grade pay either from the date of his up-gradation or from the date of his next increment viz. 1st July of the year. The pay and the date of increment would be fixed in accordance with clarification no. 2 of Department of Expenditure's O.M. No. 1/1/2008-IC dated, 13.09.2008 and subsequently revised in terms of 7th CPC. Pay fixation in the higher Grade Pay be done under the provision of FR - 22(1), (a) (1). As such, no fixation benefit shall accrue at the time of regular promotion.
8. **Grant of higher Grade Pay (through any financial benefit) may be withdrawn consequent to receipt of any clarification and/or if found inadmissible for any reason. Accordingly, the same should be rectified and adjusted.**

9. On acceptance of the financial up-gradation, the incumbent concerned will have to submit an "Undertaking" stating that in the event of any excess payment due to granting the financial up-gradation under MACP Scheme as per clarification F.No.A-26017/76/2009-Ad.IIA dated 29th September, 2009 & DoPT's latest O.M. dated 22/10/2019 and subsequently withdrawn the benefits by the Ministry, the excess payment will be refunded immediately.

10. MACP should be granted to only those officers who did not forgo their promotions before the due date of MACP which was mentioned above against each officer's name. [Reference: Point No. 24 of Annexure-I of DoPT's O.M. No. 35034/3/2015-Estt.(D) dated 22.10.2019].

He / she may further be advised to exercise option for pay fixation in the higher scale within one month. Before the implementation of pay fixation in respect of individual officers, it is advised to ensure the correctness of the name, date of birth, date of entry in the Government Service as direct recruit and date of eligibility and if any discrepancy is detected, the same may be immediately brought to the notice of this office.


