The terms and conditions of the order :-

1. On grant of financial up-gradation under the Scheme, there shall be no change in designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government

2. The MACPS contemplates merely placement on personal basis in the immediate higher Grade pay / grant of financial benefits only and shall not amount to actual/functional

3. Pay drawn in the pay band and the grade pay allowed under the MACPS shall be taken as the basis for determining the terminal benefits in respect of the retiring employee.

4. The financial up-gradation envisages retention of old designation and does not confer any

5. The financial up-gradation under the MACP Scheme shall be purely personal to the employees concerned and shall have no relevance to his / their seniority position.

6. If, financial up-gradation has been allowed due to stagnation and the employees subsequently refuse the promotion, it shall not be a ground to withdraw the financial upgradation. He shall, however not be eligible to be considered for further financial upgradation till he agrees to be considered for promotion again and the next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal.

7. With regard to fixation of his pay on grant of financial up-gradation under MACP Scheme, a Government servant has an option under FR 22 (1) (a) (1) to get his pay fixed in the higher post / grade pay either from the date of his up-gradation or from the date of his next increment viz. 1st July of the year. The pay and the date of increment would be fixed in accordance with clarification no. 2 of Department of Expenditure's O.M. No. 1/1/2008-IC dated, 13.09.2008. Pay fixation in the higher Grade Pay be done under the provision of FR - 22(1), (a) (1). As such, no fixation benefit shall accrue at the time of regular He may further be advised to exercise option for pay fixation in the higher Scale within one month.

Before implementation of pay fixation in respect of individual officer it is advised to ensure the correctness of the name, date of birth, date of entry in the Government Service as direct recruit and date of eligibility and if any discrepancy is detected, the same may be immediately
