I was transferred from Chandannagar, Hooghly, West Bengal (Kolkata Zone) to Kolkata city in April, 2013. For the period from May 2013 to till date, that is, for last seven (7) years, I have been posted in Kolkata city. In which Commissionerate or which Division or which Range I am posted has no particular meaning in my life since I do not belong to bribe seeking community of officers. But, it is only the physical distance between my residence (at Chuchura, Hooghly, West Bengal) and the location of my office that matters. When I was transferred from Chandannagar to Kolkata city in April 2013, my son was studying in Class-XII and I represented for one year retention at Chandannagar, but the prayed-for retention was not granted. Thereafter, during the last seven (7) years, I have submitted several representations seeking my transfer from Kolkata city to Chandannagar. During the last four years I have suffered the severe pains of Frozen Shoulder, first in Left Shoulder, then in Right Shoulder. I have submitted representations seeking transfer from Kolkata city to Chandannagar several times during the last four years since it was very painful and arduous to commute the journey from my residence at Chuchura to my office in Kolkata city and back with the pains of frozen shoulder.

Under this backdrop of facts, I wish to obtain the following information and copies of documents including Note Sheets under the RTI Act 2005:

- 1.a. Names of all Inspectors & Superintendents whose tenure of Posting at Chandannagar has been extended by retention at Chandannagar on representation during the last 10 years.
- 1.b. Respective grounds of retention at Chandannagar of each such officer as mentioned in Sl. No. (1.a.) above.
- 2.a. Names of all Inspectors & Superintendents who have been transferred from Kolkata city or from any outstation place of posting to Chandannagar on representation, during the last thirty (30) years.
- 2.b. Respective grounds of such transfer to Chandannagar of each such officers as mentioned in Sl. No. (2.a.) above.
- 2.c. Tenure of service in Kolkata city or any outstation place of posting of each such officer immediately preceding such transfer to Chandannagar as mentioned in Sl. No. (2.a.) above.
3. Authenticated photo copies of all representations of each such officer as referred to in Sl. No. (1.a.) and (2.a.) above.
4. Authenticated photo copies of all Note Sheets in respect of sl no. (1), (2) & (3) above.
5. Authenticated photo copies of all Note Sheets in respect of my prayer for retention at Chandannagar, which I have submitted in 2013.
6. Authenticated photo copies of all Note Sheets in respect of disposal of all my representations seeking my transfer from Kolkata city to Chandannagar, which I have submitted during the period from 01.05.2013 to till date.
- 7.a. Names of all Inspectors, Superintendents, & Assistant Commissioners who have served in Chandannagar and/or Rishra in the last 30 years.
- 7.b. Period of each posting in Chandannagar and/or Rishra of each such officer as referred to in Sl. No. (7.a.) above.
