The meeting was held under the Chairmanship of the Shri Debojit Bose, Addl. Commissioner, Kolkata South Comm'te.**

**Following facts were placed before the Departmental Promotion Committee for making the Review DPC Select Panel for the year 2003-04 to 2015-16 for promotion to the Grade of Senior Tax Assistant from the feeder Grade of Tax Assistant.**

Kolkata North Commissionerate as the Cadre Controlling Commissionerate conducted the Review Departmental Promotion Committee Meeting for 2003-04 to 2015-16 for promotion to the Grade of erstwhile Senior Tax Assistant in the combined commissionerates of erstwhile Central Excise, Kolkata- I/II/III/IV/V/ Haldia/ Bolpur/ Siliguri/ S.Tax-I/S.Tax-II/S.Tax-Audit/Durgapur/Audit-I/Audit-II/LTU and Commissionerate of Customs(P) West Bengal. Shri Debojit Bose, Addl. Commissioner of CGST & Central Excise, Kolkata South Commissionerate was designated as Chairman of the Departmental Promotion Committee by the Commissioner, CGST & Central Excise, Kolkata North Commissionerate.

In consideration with implementation of DoPT O.M. No. 20011/1/2012-Estt.(D) dated 04.03.14 and CBEC letter vide F.No. A.32022/06/2014-Ad.III.A dated 02.12.16 read with Hon'ble Supreme Court's Judgment in the case of N.R.Parmar & Ors Vs UOI, seniority list in the grade of Tax Assistant in the combined Commissionerates of Kolkata Zone had been revised and was issued on 11.09.2018. Date of effect of the aforesaid Judgement was taken as 27.11.2012 in terms of Board's letter dated 23.02.18. Seniority of the officers prior to was fixed on the basis of date arising of vacancy/issuance of advertisement w.e.f. 1986 based on decision taken by the Committee formed by the CCO vide their letter dated 20.09.17 and Chief Commissioner's approval in File No. II(39)3-ET/CON/N.R.Parmar/TA List/CGST & CX/Kol North/2018 on 22.09.17 in this regard.

In this regard a letter issued by Under Secretary vide F.No.A.32022/57/2016-Ad.III.A (Part-4) dated 26.10.2018 has been taken into consideration. According to this, Board's previous letter dated 31.08.18 which reiterated their earlier stand taken in letter dated 23.02.18 effecting N.R.Parmar Judgement from 27.11.2012 stands withdrawn and status quo may be maintained. In this Zone, the previous seniority lists issued in the light of N.R.Parmar Judgement have been effected from 1986. Thus, in this DPC also, status quo was maintained and TA seniority list issued as above was considered.

On the basis of the above mentioned TA seniority list, a Review DPC meeting for promotion to the grade of erstwhile STA was conducted for the period from 2003-04 to 2015-16.

Pursuant to the various provisions of Recruitment Rule for STA, it was noticed that the following officers have joined in the Zone on ICT basis or on the basis of Compassionate Appointment. Resultantly they have rendered the required period of eligible service but have been placed at the bottom of the seniority list on the date of their joining in the grade in Kolkata Zone. As such all the name above the mentioned officers became eligible for consideration for promotion to the grade of Sr. Tax Assistant for the year 2003-04 to 2015-16, though some of them have not rendered the prescribed qualifying period of service in the grade of TA but have crossed the probation period.

Regarding reservation for the persons with disability, there is no eligible physically handicapped officer. Total vacancy (year-wise) in all categories have been considered.

Clause included in Brief Note regarding VC/IC/ACR/APAR and passing of Examination has been considered and it has been decided that in view of passing of a period of 15 years and changed circumstance as well as promotion to higher grade of most of the officers, criteria of passing of Examination may be ignored since the grade has been abolished and the present situation was completely unforeseen. VC/IC for the relevant period may be called for only those persons who are to submit joining report in the light of preponement of date of effect of promotion. Suitable clause may be included in the Promotion Order.

In view of the above the present DPC considered the candidates who are in the consideration zone maintaining the seniority and as per cadre-wise vacancy for preparing the Review Departmental Promotion Committee Select Panel for the year from 2003-04 to 2015-16 for promotion to the Grade of Senior Tax Assistant. The Officers, who will be considered are to be



graded by the DPC as 'Fit' or 'Unfit' and those found 'Fit' are to be included in the panel as per the seniority in the feeder grade.

### **FINDINGS OF THE D.P.C.**

In view of the above, the present DPC recommends that the candidates who were in the consideration zone as per seniority for preparing the Select Panel for the year from 2003-04 to 2015 -16, for promotion to the Grade of Senior Tax Assistant (erstwhile). The Officers who are considered/not considered have been graded by the D.P.C. as 'Fit' or 'Unfit' as the case may be and those found 'Fit' are to be included in the Select Panel as per the seniority in the feeder grade.
