Now, the Board as per Commissionerate office letters dt. 31-10-2018, 23-01-2019, 25-06-2019 on the subject matter, in its letter in F. No. A-12034/60/2014-Ad.III-B (Part II), dt: 10-07-2019 has stated that the Board vide its letter dt. 19-02-2019 has already informed that the DOPT OM dated: 10-09-1993 supersedes conditions laid down in GOI OM dt: 14-05-1968 and 10-03-1986.
