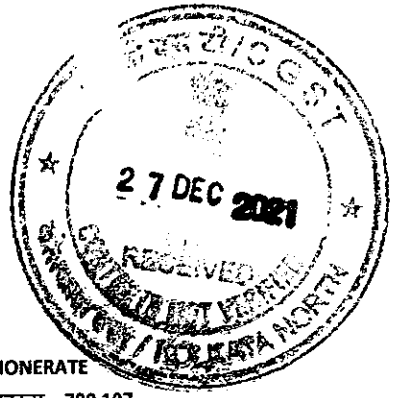

**MINUTES OF THE ANNUAL DEPARTMENTAL PROMOTION COMMITTEE MEETING
FOR THE YEAR 2020 FOR PROMOTION TO THE GRADE OF ADMINISTRATIVE
OFFICER/ASSISTANT CHIEF ACCOUNTS OFFICER FROM ERSTWHILE DOS (NOW
EXECUTIVE ASSISTANT) IN THE COMBINED COMMISSIONERATES OF CGST &
CENTRAL EXCISE, KOLKATA ZONE [KOLKATA NORTH/ KOLKATA SOUTH/
HOWRAH/ HALDIA/ BOLPUR/ SILIGURI/ AUDIT-I/ AUDIT-II/ DURGAPUR
AUDIT/ APPEAL-I/APPEAL-II/SILIGURI APPEAL AND COMMISSIONERATE OF
CUSTOMS (PREVENTIVE) WEST BENGAL].**

The Annual Departmental Promotion Committee meeting for the year 2020 for regular promotion to the Grade of Administrative Officer/Assistant Chief Accounts Officer from erstwhile DOS (now Executive Assistant) in the combined Commissionerates of CGST & Central Excise, Kolkata Zone [Kolkata- North/ South/ Howrah/ Haldia/ Bolpur/ Siliguri/ Durgapur/ Durgapur Audit/Siliguri Appeal/Appeal-I/II/Audit-I/II and Commissionerate of Customs (P), W.B.] was held under the Chairmanship of Shri Roopam Kapoor, Principal Commissioner, CGST & Central Excise, Kolkata North Commissionerate on 25.09.2020 at 11:30 hrs.

The Departmental Promotion Committee comprised of :

DPC was informed that the Sanctioned Strength of Administrative Officer / Assistant Chief Accounts Officer in these combined Commissionerates is 100 (UR 77, SC 15, ST 08) and the working strength is at present 42 (UR 33, SC 08, ST 01). Therefore there are 58 vacancies for the year 2020. These 58 vacancies include 44 UR, 07 SC and 07 ST vacancies (including one vacancy that has occurred recently due to demise of one UR officer in the grade of AO, namely Late Arun Kumar Kundu (DOB - 30.06.69 and D.O. Death - 04.04.2020).

Therefore, the present DPC prepared the Annual DPC Select panel for 2020 for regular promotion to the Grade of A.O./A.C.A.O. for filling up 58 vacancies as per availability of eligible officers.

According to the Recruitment Rules in the Grade of Administrative Officer/Asstt. Chief Accounts Officer issued by Ministry of Finance, Department of Revenue vide G.S.R. 305(E) Dated 21.05.2020, Executive Assistants (erstwhile DOS/ erstwhile STA in GP Rs. 4200, Level 6) with 5 years of regular service in the grade with successful completion of training for 2-4 weeks as specified by the CBIC, are eligible for such promotion. Thus, the officers who have joined as erstwhile DOS/ erstwhile STA in GP Rs. 4200/- (now Level 6) on or before 01.01.2015 and have completed five years of regular service as on 01.01.2020 with successful completion of training for 2-4 weeks conducted by NACIN (Kolkata), are eligible for promotion to the Grade of Administrative Officer / Asstt. Chief Accounts Officer in the Annual DPC for the year 2020.

Furthermore, it is also worthwhile to mention that, in the RR of AO published on 21.05.2020, under "Special Provision" point no. (3), it is clearly mentioned that:

"The post of Deputy Office Superintendent shall be placed en-bloc senior to the post of Senior Tax Assistant and the service rendered in the grade of Deputy Office Superintendent and Senior Tax Assistant shall be counted towards the eligibility for promotion to the next higher grade."

The seniority list of Executive Assistant is yet to be finalized due to non-finalization of draft seniority list of erstwhile STA dated 14.11.2018 (as per N R Parmar w.e.f. 2003 onwards) and Board's recent instruction vide letter dated 04.08.2020. It is also worthwhile to mention that the seniority lists in the grade of STA, TA and LDC w.e.f. 1986 onwards in the light of N R Parmar Judgment, are subjudiced at this juncture before the Court of Law in the cases of S/Sri Sukumar Kundu, Baladitya Barik and Shyam Sundar Sethi. The post of Executive Assistant (GP Rs. 4200, now Level -6) is comprised of erstwhile DOS and erstwhile STA in same GP / Pay Level, where erstwhile DOS would be placed en-bloc senior to erstwhile STA [officiating as DOS (erstwhile), now Executive Assistant, by nomenclature]. Thus, erstwhile DOS will be always senior to the erstwhile STAs, either N.R. Parmar judgement w.e.f. 1986 onwards or 27.11.2012 onwards or in the post scenario of Hon'ble Supreme Court's Judgement in the case of K. Meghachandra Singh (Date of Joining). Also, there is no dispute or litigation pending regarding the draft seniority list of erstwhile DOS published on 15.07.2020 as well as final seniority list of erstwhile DOS published on 30.07.2020.

As per norms of Swamy's Handbook normal consideration should be $(58 \times 1.5 = 87) + 03 = 90$. Therefore, total 90 (Ninety) officers can be included in the consideration zone. However, there are only 08 officers (SI No. 2, 6, 15, 19, 23, 27, 32 & 34) available in the seniority list of erstwhile DOS issued on 30.07.2020, and who are also eligible to come under the consideration zone as per norms. However, one (01) officer under serial no 15, namely Smt. Anjela Ekka (D.O.B. 02.01.1965) has submitted her non-willingness for accepting promotion to the grade of Administrative Officer and also not attended the mandatory training for promotion to the grade of AO conducted by NACIN, Kolkata held from 07.09.2020 to 21.09.2020.

According to the existing 200 Post Based Reservation Roster as per D.O.P.T. O.M. dated, 02-07-1997 clarified vide O.M. dated, 11-07-2002 read with O.M. dated, 10.08.2010, against 100 number of Sanctioned Strength, representation of Scheduled Caste and Scheduled Tribe Officers should be 15 and 08 respectively. As on date, the actual representation of Scheduled Caste and Scheduled Tribe Officers in the Grade of A.O. / A.C.A.O. in these combined Commissionerates are 08 and 01 respectively. Therefore the present DPC considered 07 SC officers and 07 ST Officers on reserve quota, subject to availability of eligible Officers. In this regard, it is to be mentioned that the position as stated above has duly been communicated to the Liaison Officer for SC/ST, seeking requisite certificate of SC/ST reservations, as mentioned above and accordingly the Liaison Officer for SC/ST issued her certificate "that the number of posts in the AO/ACAO grade for SC/ST appears to be in order" through her letter dated 26.02.2020.

According to the D.O.P.T. O.M. No. 22011/2/2002-Estt.(D) dated 06-01-2006, it has been decided by the Government that there shall be no supersession in the matter of 'selection' promotion and the officers are to be graded by the DPC as 'Fit' or 'Unfit'. The prescribed benchmark is 'Good' and those found 'Fit' are to be included in the panel as per the seniority in the feeder grade.

Addl./Joint Commissioner (P&V), CGST & Central Excise of the concerned Commissionerates rendered the requisite Vigilance Clearance certificate in respect of the officers who were placed in the consideration zone for promotion. Moreover, records of the service of the officers who have been empanelled for promotion have been carefully scrutinized and certified by the concerned competent authority that there is no doubt about their integrity. Considering all the facts, the present DPC has been satisfied in regard to Vigilance Clearance and Integrity of the officers who have been empanelled for promotion. Moreover, as per rule the DPC has duly checked the concerning ACR/Dossier of the empanelled officers.

Considering all the facts as stated above, recommendation of the Annual Departmental Promotion Committee for the year 2020 for promotion to the grade of A.O./A.C.A.O. from erstwhile DOS (now Executive Assistant) in Kolkata Zone, against each individual is appended below.

A draft Seniority List of Deputy Office Superintendent (erstwhile) in the Combined Cadre of CGST & Central Excise, KOLKATA NORTH/ SOUTH/ HOWRAH/ HALDIA/ BOLPUR/ SILIGURI/ DURGAPUR AUDIT/ SILIGURI APPEAL/ APPEAL-I/ APPEAL-II/ AUDIT-I/ AUDIT-II and COMMISSIONERATE OF CUSTOMS(P) WEST BENGAL as on 28.09.2015 was published on 26.07.2016, consisting of 34 no. of officers. But, in due course, 26 number of officers (Serial No. 1, 3, 4, 5, 7, 8, 9, 10, 11, 12, 13, 14, 16, 17, 18, 20, 21, 22, 24, 25, 26, 28, 29, 30, 31, 33) were promoted to higher grade / retired from service. At present, there are only 8 (eight) number of existing officers (Serial No. 2, 6, 15, 19, 23, 27, 32, 34) working as erstwhile DOS (now Executive Assistant) in this Zone.

Since then, as no representation has been received, no change in the draft seniority list of erstwhile DOS post has been occurred till date.

Furthermore, it is worthwhile to mention that, RRs of Executive Assistant was issued on 28.09.2015 merging upon erstwhile DOS and erstwhile STA post. Hence, erstwhile DOS post and erstwhile STA post became non-existent w.e.f. 28.09.2015, i.e. from the date of issuance / publication of EA RR.

Hence, the draft seniority list of Deputy Office Superintendent (erstwhile) as on 27.09.2015, consisting of 34 (thirty four) candidates, is again published on today i.e. 15.07.2020 in respect of Kolkata Zone.

Any objection/representation in this regard addressed to the undersigned should be forwarded through proper channel within 15 (fifteen) days of the publication of the draft seniority list.

The general principle for determining seniority in Central Service as laid down in the DOPT's O. M No. 20011/1/2008-Estt.(D) dated 11.11.2010 have been followed.

The Draft Seniority List may be given a wide circulation.



Sub : Promotion to the grade of Administrative Officer (A.O.)

The sanctioned strength in the grade of A.O. in this zone is 100. Presently, there are 61 no. of officers working in the grade. Moreover, 18 officers have been promoted to the grade of C.A.O. (on in-situ basis). So, a huge vacancy of 57 is arising in the grade (100-61-18=57), which is required to be filled up through promotion during the year 2020.

It is to mention that, new RR in respect of the grade of A.O. from the feeder grade of Executive Assistant is still awaited. In this scenario, as per Rule, promotion may be granted as per existing RR, i.e. RR of A.O. dated 03.10.2013. The Rule says:

"Ad hoc appointments are also frequently resorted to on the ground that proposals are under consideration to amend the existing Recruitment Rules. The legal position in this regard is that, posts are to be filled as per eligibility conditions prescribed in the rules in force at the time of occurrence of the vacancies unless amended Recruitment Rules are brought into force with retrospective effect. In fact, the practice has been to give effect to amendments in the Recruitment Rules only prospectively, except in rare cases. Hence, regular appointments/promotions may be made in all such cases in accordance with the Recruitment Rules in force at the time when the vacancy arises. No ad hoc appointments/promotions may be made on the grounds that the Recruitment Rules are being revised or amended."

As per existing RR of A.O., the officers in the grade of DOS with 5 years of regular service are eligible for promotion to the grade A.O. the posts 'STA' and 'DOS' were merged and a new post 'Executive Assistant' was created. RR of EA was published on 28.09.2015. It is also to be mentioned that, seniority list of EA could not be finalised as per Board's instruction to maintain "status quo" (letter dated 26.10.2018 and clarification dated 04.02.2019). However, as per previous undisputed seniority list of DOS dated 28.09.2016, 5 number of officers in the grade of DOS (re-designated as EA) are eligible for promotion to the grade of A.O., as per the existing RR of A.O. dated 03.10.2013.

If approved, process for promotion to the grade of A.O. for the year 2020 with reference to existing RR of A.O. dated 03.10.2013 will be started.

This unit has received a letter dated 23.12.2019 from the All India Central Excise & Service Tax Ministerial Officer's Association regarding promotion to the grade of Administrative Officer from the grade of Executive Assistant.

As per Rules, existing RR should have to be followed for promotion till finalisation of new/ revised RR in the promotee grade. (copy of rule placed in file)

Although the posts DOS and STA have been re-designated as E.A. and RR of EA has been published on 28.09.2015, but new RR of Administrative Officer has not yet been published.

As per existing RR of A.O. dated 03.10.2013, DOS with 5 years of regular service are eligible for promotion to the grade of A.O.

Accordingly, VC & IC of 5 (five) DOS (now EA) has been called for vide letter dated 13.12.2019.

Now, the Association vide letter dated 23.12.2019 has demanded for promotion to the grade of AO from the grade of EA as per guidelines of DoPT dated 31.12.2010 regarding revision of framing/ amendment/ relaxation of RR. Although the seniority list of EA has not yet been published due to pending of finalisation of STA seniority list.

It has also been pointed out that as per draft RR of AO, EA with 5 (five) years of regular service and successfully completion of training for 2-4 weeks are eligible for promotion to the grade of AO. The finalisation of draft RR of AO has not yet been done.

The sanctioned strength in the grade of A.O. in this zone is 100. Presently, there are 42 no. of officers working in the grade. Therefore, a huge vacancy of 58 is arising in the grade (100-42=58), which is required to be filled up through promotion during the year 2020.

It is further to mention that process of DPC for promotion to the grade of AO was initiated by taking into account the old RR of AO. The Principal Chief Commissioner directed to send all the correspondences to the CCO. However, the DPC could not be held till date and in the meantime, new RR of AO has been published on 21.05.2020. Therefore, DPC cannot be done by taking old RR and the process may be re-initiated.

It is to mention that, in the new RR in respect of the grade of A.O. from the feeder grade of Executive Assistant, where the eligibility for promotion to the grade of AO has been mentioned as under:

"Executive Assistant under the Central Board of Indirect Taxes and Customs in level-6 in the pay matrix (Rs. 35400-112400) with five years regular service in the grade and have successfully completed training for 2-4 weeks from the institute or organisation as specified by the Central Board of Indirect Taxes and Customs."

Furthermore, it is also worthwhile to mention that, in the RR of AO published on 21.05.2020, under "Special Provision" point no. (3), it is clearly mentioned that:

"The post of Deputy Office Superintendent shall be placed en-bloc senior to the post of Senior Tax Assistant and the service rendered in the grade of Deputy Office Superintendent and Senior Tax Assistant shall be counted towards the eligibility for promotion to the next higher grade."

The seniority list of Executive Assistant is yet to be finalised due to non-finalisation of draft seniority list of erstwhile STA dated 14.11.2018. 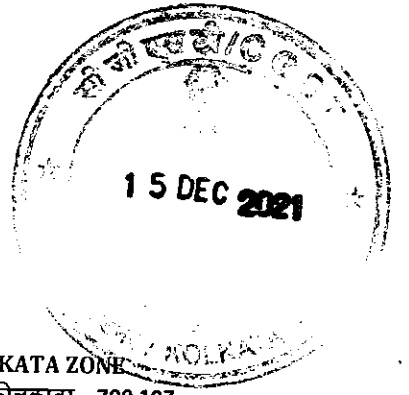


