The point wise reply of the above said RTI application are given as under:

Point No. 1 to 5- Not pertaining to this office.

Point No. 6- No such information is available with the undersigned.

Point No. 7- The rule governing of the wearing of uniform under the Central Board of Indirect Taxes & Customs for GST officers is same as that of Central Excise and Customs officers prevailing before 01.07.2017.

Point No. 8- All Central Excise and Customs Officers of and below the rank of Assistant Commissioner including officers of the Preventive Intelligence Branch must wear uniform when on duty, both in their offices and on tour. Where it is considered necessary for an officer to conceal his indentity in connection with any special job, the officer must obtain parior permission of his controlling officer to be on duty without wearing uniform. Where, however, it may not be possible due to unforeseen circumstances to obtain prior approval, the Officer may perform the special duty in plain clothes but the immediate superior officer must be informed immediately, and on such occasions the Officer must carry with him the identity card issued to him by the Collector. Permission in such cases should be restricted to specified occasions and general relaxations from wearing uniforms should not be permitted for any grade of officers without the Board's prior approval. Circle and Divisional Officers are responsible for ensuring that their field staff wear prescribed uniforms at all times when on duty. The Customs Officers employed on Preventive Intelligence work are exempt from wearing uniform except on special and ceremonial occasions.

Point No. 9- The purpose to wear Uniform under the Central Board of Indirect Taxes & Customs for GST officers is to maintain and encourage a proper sense of discipline.
