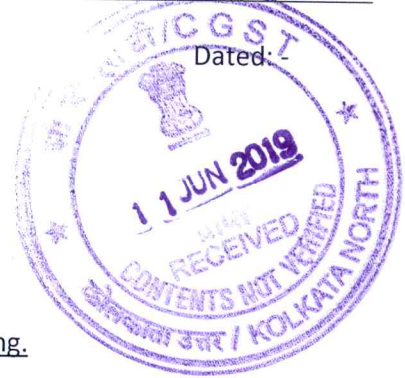

Para D. FR 56(J) is not proposed against any of the officers as on 01.03.2019

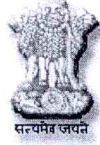
