
SUB: Service particulars regarding my father Retired Inspr Radhanath Tripathy, Central Excise (Last known designation as Superintendent of Central Excise)

Respected Sir,


I state the lines below for your kind consideration and necessary action please. My father Shri Radhanath Tripathy was posted in various offices of CBEC during his service tenure under KOLKATA-I, BOLPUR, HALDIA Excise Commissionerates as per hearsay and our scant information. He has deserted me (his only son) and my mother, Smt Subasini Tripathy since the year 1996, after marrying Smt Basantilata of Bamnal, Puri, Odisha and had kept the matter and his whereabouts hidden from all till date by declaring his first wife to be dead and that he had no children before, in his official records. My mother had approached BOLPUR Commissionerate, Central Excise, and she was directed to DURGAPUR-I Division, in 23 Dec 1997, where she submitted a plea regarding our trauma, but to no avail (copy attached). Henceforth, my mother didn't want to disturb him anymore, lest her husband be harassed officially. Now even after his retirement some years before, he has never enquired if we were alive or not, even for moral sake. Hence at the behest of my old age mother, I request the following particulars of my father so as to know about his well being at least and to initiate legal action if deemed necessary. An early action is requested please.
