Background of the information: Recruitment of Inspectors (Central Excise) is being done by the department after getting recommendation from Staff Selection Commission (SSC) on the basis of All India Combined Graduate Level Exam (CGL) since 2003 in light of the judgment of Hon'ble Supreme Court of India dated 09.12.1996 in Radhey Shyam Singh & Ors vs UOI & Ors by which process of recruitment on the basis of zonal selection was quashed. Further, the seniority of all direct recruitee has to be maintained as per the guidelines of DoPT OM 22011/7/86- Estt. (D) dated 03.07.1986 throughout the service career of such recruitees.

Now, I want to get following information point-wise in compiled manner from your good office and shall remain thankful for the same:

1. List of Inspectors joined under recommendation from SSC on the basis of result of CGL 2003 and posted in the Kolkata Zone along with their merit Rank/ Position in SSC CGL Exam 2003 and options received from such recruited inspectors regarding zonal placement.
2. Status of their promotion as on 31.01.2020 in next grade with date of promotion.
3. Status of promotion as on 31.01.2020 from Inspector to Superintendent in r/o SSC CGL batches i.e. upto which batch promotion completed/running/under consideration zone for coming promotion.
4. Whether the promotions are being done in consideration with the DoPT OM No. 22011/7/86- Estt. (D) dated 03.07.1986 protecting their All India SSC merit rank/position secured by them in respective CGL Exams? If deviation, reason thereof.
5. Copies of note sheets of the file dealing with promoting inspectors to the grade of superintendent.

Reply of Point No. 3 -

The last Annual DPC for the period of 2017-18 for promotion to the grade of Superintendent was held on 30.03.2017, by considering the Seniority list of Inspectors published on 30.11.2015 issued by the erstwhile Central Excise Kolkata-II Commissionerate. The said Draft Seniority list of Inspector as on 01.04.2015 in the Central Excise Kolkata Zone was issued on 30.11.2015 vide Office Memorandum under C.No.II(34)1-DPC/Kol-II/2012/12335-55B dated 30.11.2015.

Consideration Zone of any promotion is being prepared by the existing Seniority List of the feeder grades, not by specific batch-wise.
