In the case of fresh allotment of the officers who are not entitled for the above type quarter O.M. No. 18011/2/90-Pol.III dated 13.10.2003 may be referred to which inter alia states, "It has been decided that in all cases where, due to adequate availability of quarters of a particular type a Government employee is allotted accommodation of a type which is higher than his entitlement, only flat rate of Licence Fee relevant to that type of accommodation is to be charged from such allottee. However, three times the normal rate of licence fee is to be charged from those Government employees who are allotted, out of turn, Government accommodation of a type higher than their entitlement at their own request, despite there being no surplus quarters in that type."

All the above mentioned officers are not entitled for Type-IV quarter and requested for the higher type quarter on their own due to personal/medical reason mentioned in their applications as shown below -

- ① Date of Joining
- ② Medical grounds alongwith all the supporting documents
- ③ ~~Best~~ Applications from those who are not residing in any Type of Quarters at present (because majority of applications fall in the second criteria as above and thus for a fair and transparent allotment this criteria may be adopted).

Although in the notesheet willingness to pay three times licence fee has been quoted but that is not a matter of choice so that may be dispensed with.

By following the above three criteria we may allot the vacant quarters, if approved. The three applicants falling in the above criteria are Sl.no. 3, 16 and 13 (who is in Type II as opposed to other applicants who are residing in Type III at present).
