Sir/Madam,

With due respect, I the holder of abovementioned original PPO, beg to state that I have a wholly dependent Handicapped son, Shri Mithun Barik (Hearing and speaking disability 100%). Before retirement I was not aware of the family pension in respect of handicapped child. However later on Commissioner of Central Excise, Kol-I Commissionerate vide C. No. II(25)108/Pen/AC/Kol-I2004/236ac dated 21.04.2005 (copy enclosed) had sanctioned Family Pension throughout the life of Sh Mithun Barik as per Rule 54(6) of CCS Pension Rules, 1972.

In the present circumstances, keeping in view quantum of disability, I pray to your good self to co-authorise the name of my handicapped son Sh Mithun Barik as a family pensioner as per CPAO OM No CPAO/Tech/Simplification/2013-14/252 dated 06/02/2014.

I will be grateful if you kindly make an arrangement to issue amendments to the Special Seal Authority and issue the same to all concerned for authorization of family pension to my permanently disabled son.
