REVIEW DEPARTMENTAL PROMOTION COMMITTEE MEETING FOR THE PERIOD FROM 18.12.13 TO 27.09.15 FOR PROMOTION TO THE GRADE OF EXECUTIVE ASSISTANT FROM THE FEEDER GRADE OF TAX ASSISTANT IN COMPLIANCE WITH BOARD'S (CBIC) INSTRUCTION DATED 13.11.2020 AND SUBSEQUENT CLARIFICATION DATED 06.01.2021 IN THE COMBINED COMMISSIONERATE OF CGST & CENTRAL EXCISE, KOLKATA ZONE [KOLKATA- NORTH/ SOUTH/ HOWRAH/ HALDIA/ BOLPUR/ SILIGURI/ DURGAPUR AUDIT/SILIGURI APPEAL/APPEAL-I/II/AUDIT-I/II AND COMMISSIONERATE OF CUSTOMS (P), WEST BENGAL], WILL BE HELD ON 11.02.2021 (THURSDAY) AT 12:00 HRS.

Review DPC meeting for the period from 18.12.2013 to 27.09.2015 with respect to the promotion to the grade of Executive Assistant from Tax Assistant in compliance with Board's (CBIC) instruction dated 13.11.2020 and subsequent clarification dated 06.01.2021, in the Combined Cadre of CGST & Central Excise, Kolkata- Zone is scheduled to be held on 11.02.2021 at 12:00 hrs. under the Chairmanship of Shri Pradeep Kumar Bohra, Additional Commissioner, CGST & Central Excise, Kolkata North Commissionerate.

It is informed that the Board Office (CBIC) has issued an instruction to all CCAs under F. No. A.32011/03/2015-AD.III.A dated 13.11.2020 with regard to examination of promotion to the grade of Executive Assistant cadre during 18.12.2013 to 28.09.2015. The relevant part of Board's letter dated 13.11.2020 is reproduced below:

"2. It is directed as under, on the applicability of Recruitment Rules (RRs) for promotion of EA cadre-:

(a) The post of STA/DOS were in existence prior to 18.12.2013, i.e., up to 17.12.2013. Any pre-cadre vacancy i.e. vacancies arising out of the grade of STA and DOS up to 17.12.2013 were to be filled by the RRs in force on the date on which vacancy arose, i.e. RR of 2003 for STA and RRs of 2009 for DOS.

(b) Post Cadre restructuring i.e. from 18.12.2013 and up to the date of notification of RR of EA i.e. 28.09.2015 (intervening period between date of issue of Cadre restructuring order and date of notification of RRs of EA 2015), the cadre restructuring order provides that DOPT's guidelines on RRs dated 31.12.2010 be used for filling up re-designated posts. Thus, DOPT guidelines on RRs are to be operated for convening DPC/Review DPC for all vacancies arising between 18.12.2013 to 27.09.2015. Attention is drawn specifically to Para 3.1.3 of DOPT guidelines on 'protection clause' in this regard. The provision in cadre restructuring order mentioned above read together with Para 3.1.3 of DOPT guidelines implies that those in feeder cadre on 18.12.2013 can be promoted as EAs as per qualifying service of old RRs.

(c) Post notification of RR for the Grade of EA 2015 i.e. from 28.09.2015, any vacancy in the grade of EA would be filled as per the provisions of RRs of EA notified on 28.09.2015.

3. It is thus clear that irrespective of date of holding DPC, all vacancies in EA cadre that arose prior to notification of RRs of EA 2015 (i.e. upto 27.09.2015) can be filled up as per qualifying service of RRs of STA 2003/DOS 2009. Any promotions in vacancies on or after the date of cadre restructuring (18.12.2013) but upto 27.09.2015 should be to the post of 'EA' only and should refer to DoPT guidelines of 2010 (and not old RRs). CCAs who did not follow this procedure may convene review DPCs to use correct terminology as indicated above. CCAs who have not carried out any promotions for vacancies during 18.12.13 to 27.09.15 may convene fresh DPCs to consider eligible persons in feeder cadre for promotion to EA quoting

- Therefore, it is once again reiterated that the benefit of three years qualifying service in terms of para 3.1.3 of DoPT guidelines of 2010 is to be extended strictly subject to fulfilment of the following conditions:
- a) The official should have been in the feeder cadre of that particular zone before 18.12.2013
- *b)* The official should have completed three years qualifying service before EA RRs of 2015 came into effect
- c) There were vacancies in EA cadre during the intervening period between issue of cadre restructuring order and notification of EA RRs of 2015 (i.e. period of 18.12.2013 and 27.09.2015)"

2.1 The Review DPC has been informed that the post of Tax Assistant was the feeder cadre for promotion to the grade of erstwhile Senior Tax Assistant.

<u>RRs of STA, 2003</u>: As per Schedule 12, "*Tax Assistant with 3 years of regular service* in the grade and have passed the departmental examination as specified by the Competent Authority from time to time in computer application and relevant procedure."

RRs of DOS, 2009: As per Schedule 12, "Senior Tax Assistant with three years regular service in pay band Rs. 93000-34800/-"

2.2 As per Note in Column 12 of RRs of STA, 2003, it has been specified that, "if a junior person is considered for promotion on the basis of his completing the prescribed qualifying period of service in that grade, all persons senior to him in the grade shall also be considered for promotion, notwithstanding that they may not have rendered the prescribed qualifying period of service in that grade but have completed successfully the prescribed period of probation."

2.3 The instruction regarding consideration of seniors has also been clarified by DOPT in its OM No. AB. 14017/48/2010-Estt.(RR) dated 31.12.2010. The relevant part 3.1.2 of the said OM is reproduced as below:

"3.1.2 It may so happen that in some cases of promotion, the senior officers would not have completed the required service whereas the juniors would have completed the prescribed eligibility condition for promotion. In such cases, seniors will be left out from consideration for the higher post. To avoid such a situation, following note may be inserted in the recruitment rules/column in the schedule to the Recruitment Rules.

Note:

Where juniors who have completed their qualifying / eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying / eligibility service by more than half of such qualifying / eligibility service or two years, whichever is less, and have successfully completed probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying / eligibility service."

3. The Board Vide F.No. 10C18/3/2017 -Ad.II.B dated 04.07.2018 directed that, "The Department of Personnel and Training has issued OM No. 36012/11/2016-Estt. (Res-I) (Pt.II) dated 15.06.2018 directing that promotions are being carried out, in accordance with the directions of Hon'ble Supreme Court mentioned in paragraphs 2 & 3 of the DOPT OM dated 15.06.2018 based on existing seniority / select lists, subject to the further orders of SLP by the Hon'ble Supreme Court."

In terms of DOPT OM dated 15.06.2018 issued under F.No. 36012/11/2016- Estt(Res I) (Pt II) at Para 2 & 3 has explicated as under :

Para 2. The Hon'ble Supreme Court in SLP (C) No. 30621/2011 has passed the following order on 17.05.2018.

"It is directed that the pendency of this Special Leave Petition shall not stand in the way of Union Of India taking steps for the purpose of promotion from 'reserved to reserved' and 'unreserved to unreserved' and also in the matter of promotion on merits......"

Para.3. Further, in the matter related to SLP (C) No. 31288/2017, connected to Special Leave to Appeal (C) No. 28306/2017, the Hon'ble Supreme Court held as under on 05.06.2018:

"Heard learned counsel for the parties, Learned ASG has referred to order dated 17.05.2018 in SLP (C) No. 30621/2011. It is made clear that the Union of India is not debarred from making promotion in accordance with law, subject to further orders, pending further consideration of the matter. Tag to SLP (C) No. 30621/2011"

5. Accordingly, officers whose promotion will be reviewed in the Review DPC, may only be allowed to join after ascertaining their VC/IC & major/minor penalty (clear from all angles on the date of effect of their promotion) alongwith synopsis of APAR (minimum Benchmark is 'Good') before the date of effect of their promotion, by the concerned Commissionerate wherein the officers are presently posted.

6.1 The sanctioned strength in the grade of EA in this zone is (434) since 18.12.2013 onwards. The details of vacancy positions in the grade of Executive Assistant for the period from 18.12.2013 to 27.09.2015, in this CGST & Central Excise, Kolkata Zone are as under-:

In this regard it is mentioned that the vacancy positions as stated above has duly been communicated to the Liaison Officer for SC/ST, seeking requisite certificate of SC/ST reservations, as mentioned above and accordingly the Liaison Officer for SC/ST issued her verification certificate "that the number of posts in the Executive Assistant grade for SC/ST appears to be in order" through her letter.

6.2 The Zone of consideration for this Review DPC has been prepared as per DoPT OM No. 220/11/2/2002-Esstt.(D) dated 06.01.2006 and extended upto the last officer in the grade of Tax Assistant who joined in this Zone prior to 18.12.2013, , which is placed at **Annexure-I** (containing serial no. 1 to 215, twenty three pages).

Part-I

7.1 The Review DPC is being informed that the following DPCs for promotion to the grade of erstwhile STA from the grade of TA were conducted in this Zone on or after 18.12.2013 by considering RRs of STA, 2003-:

measures as per the latest instruction/clarification given by the Board. Few officers among them will be subsumed/adjusted against EA vacancies arose between 18.12.2013 to 27.09.2015 & rest of the officers will not be considered in the Review DPC due to ineligibility and hence will be reverted back to the feeder grade, i.e. TA from Ad-hoc EA. In this regard, a separate list of officers who have joined in this zone between 18.12.2013 and 27.09.2015, and who were promoted to the grade of STA on ad-hoc basis, is placed at **Annexure-II** – (containing serial no. 1 to 112, nine pages).

It is worthwhile to mention that many officers who are likely to come under the purview of the upcoming Review DPC, were already promoted to the grade of Inspector on adhoc basis from STA. Therefore, after the proposed Review DPC, a Review DPC in the grade of Inspector will be required for corrective measure as per Board's latest instruction/clarification. Accordingly, the Cadre Controlling Authority for Inspectors, i.e. Howrah GST Commissionerate is required to hold Review DPC in this regard.

7.2 Board had earlier issued a letter dated 01.07.2019 regarding irregularities in promotion in respect of Group 'B' (non-gazetted) & 'C' posts, under CBIC, wherein it was directed to conduct Review DPCs by taking corrective action based on the relevant RRs/ DoPT guidelines. In this CCA (Zone), a DPC (mentioned in SI. 7 of para 2.4 above) was conducted as per SI. No. 3 in Board's letter dated 01.07.2019.

7.3 After that, few officers who were promoted in the DPC dated 23.06.2017, filed an O. A. No. 350/984/2019 and MA No. 350/530/2019 and R.A. No. 19/2019 in the matter of Shri Kumar Saurav Das & Ors vs U.O.I & Ors before the Hon'ble CAT, Kolkata Bench. However, this is to mention that no Stay Order has been imposed by any Court of Law for implementing Board's latest instruction dated 13.11.2020 and further clarification dated 06.01.2021 in respect of this Zone. In this regard, the reply of CAT Cell, Kolkata North Comm'te has been placed at **Annexure-III**.

Part-II

8.1 Further, the Review DPC is being informed that for the purpose of the Review DPC in compliance with the latest instruction issued by the Board Office, the eligibility criterion to be taken is as per the old RRs (RRs of STA, 2003) in the erstwhile promotional cadre of Senior Tax Assistant i.e. 3 years of regular service in the feeder grade i.e. Tax Assistant as mentioned in para 2 above. According to DOPT's O.M dated 31.12.2010 and RRs of STA, 2003, those officers who are senior in the consideration list and who have at least completed their probation period of 2 years and passed the Departmental Examination for promotion to the grade of EA are also eligible for promotion to the grade of EA as per the provisions of junior senior clause mentioned in above said RRs of STA 2003 and Para 3.1.2 of DOPT OM dated 31.12.2010.

8.2 The consideration list for Review DPC for the period 18.12.2013 to 27.09.2015 with respect to promotion to the grade of EA from TA is placed at Annexure-I (as already stated above at para 6.3).

9. This office is also in receipt of representations from few officers in this regard which is placed at **Annexure-IV**.

10. The aforesaid details along with the relevant documents/ records are to be placed before the Review DPC for recommending a panel of candidates for the aforesaid vacancies of Executive Assistant.

Draft Seniority List in the Grade of LDC in the combined Commissionerate of Kolkata-I/II/III/IV/V/VI/VI/Haldia/Bolpur/ Siliguri/ Service Tax/ Audit/ LTU and CC)P) as on 31.08.12, has been taken into consideration for determination of the date of entry into Central Services and period of service rendered by the individuals. Further, according to the Recruitment Rule of TA dated 10.01.2014 [G.S.R. 12 (E)] prescribes the following eligibility under Note-1 of Column 11 :

Where juniors who have completed this qualifying or eligibility service are being considered for promotion, their seniors shall also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years whichever is less and having successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.'

Shri Gopal Chandra Sardar, LDC , Seniority list No 30 of the seniority list of TA as on 31.08.12 has completed 08 years of combined regular service in the grade of Havaldar and LDC and satisfies the criteria of the required educational gualification and has passed the Departmental Examination and is therefore eligible for promotion to the grade of Tax Assistant. In view of the above, and following the Recruitment Rule of Tax Assistants, the officers senior to him according to the Seniority list of TA as on 31.08.12 may also be considered for promotion provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years whichever is less and having successfully completed their probation period for promotion to the next

Another issue relates to Shri Sanat Naskar, LDC presently posted in CCO. MOF. The dispute whether in the case of ICT, the past service rendered by a candidate in his pa Commissionerate should be counted towards the qualifying service in the present Commissione has been settled by the Principal Commissioner and he has decided in favour of counting the service as per the Board's Instrcutions.

Therefore, following the same analogy, Shri Naskar, LDC, who joined this zone from the D MOF after rendering 15 years of service is also eligible. The DPC may therefore decide whether consider the past service in the grade of LDC of Shri Naskar while counting his qualifying service promotion to the grade of Tax Assistant.

Further, if the DPC decides to count the past service of Shri Naskar then according to the Recruitment Rule of TA 2014 [G.S.R. 12 (E)] which prescribes the following eligibility under Noteprovided they are not short of the requisite qualifying or eligibility service by more than half of suc qualifying or eligibility service or two years whichever is less and having successfully completed the probation period for promotion to the next higher grade, the officers senior to him according to the Seniority list of TA as on 31.08.12 should also be considered for promotion.

Sanctioned Strength in the Grade of Tax Assistant is 39 in promotion quota. Working Strength is 01. There are 38 existing regular vacancies. However there are only 16 eligible officers, if the candidature of Shri Sanat Naskar is also admitted, (including 02 officers who have already been considered for ad hoc promotion to the grade of Tax Assistant) in the consideration zone for promotion to the grade of Tax Assistant.

As per Post Based Roster, against 39 posts in the grade of Tax Assistant, the representation of SC category should be 05 and that of ST category should be 02. However, the actual representation of SC and ST Officers at present is NIL. As such, there is shortage of 05 SC and 02 ST Officers in the Grade of TA. All the 16 officers shall be promoted against unreserved quota and the SC/ST posts shall remain vacant. i.e. the SC/ST candidates shall be promoted on their own merit against the unreserved vacancies. Therefore it was decided to carry forward the 05 SC and 02 ST posts as backlog vacancies of the year 2016-17.

Shri S.R. Meena, Addl. Commissioner, Central Excise, Haldia Comm'te and Liaison Officer for SC/ST was informed about the position of the SC/ST officers with the request to issue necessary certificate in regard to SC/ST reserved points. The report of the Liaison officer has not yet been received. However in view of the above fact that the reserved quota is being filled up with available eligible candidates and the decision of the DPC is not affected in absence of the LO's certificate.

Kolkata-I Commissionerate as the Cadre Controlling Commissionerate will conduct the Annual Departmental Promotion Committee Meeting for the year 2017-18 for promotion to the Grade of Tax Assistant in the combined cadre of Kolkata-I / II / III / IV / V / Haldia / Bolpur / Siliguri / S.Tax-I / S.Tax-I / S.Tax-Audit / Durgapur / Audit-I / Audit-II / LTU and Commissionerate of Customs(P) West Bengal . Shri R.K.Misra, Additional Commissioner of, S.Tax-Audit, is designated as Chairman of the Departmental Promotion Committee.

The Recruitment Rule of TA dated 10.01.2014 [G.S.R. 12 (E)] followed by a notification vide G.S.R.710(E) duted 15.09.15(ANNEXURE-A) prescribes the following eligibility:

Lower Division Clerks who have rendered 8 years of regular service in the grade Failing which 8 years of combined regular service in the grade of LDC and Havaldar shall be taken into consideration and **uhould** possess the following educational qualification and experience namely :

(a) 12th Class or equivalent from a recognized Board or University

(b) Data Entry speed of 8000 key depression per hour for data entry work and passed the departmental **examination** with typing speed of 35 words per minutes in English or 30 words per minute in Hindi on **Com**puter.

The it is informed that according to CBEC's letter vide F.No.A-11013/27/2012-Ad.IV dated 02.17(ANNEXURE-B) regarding merger of grades of Sepoy and Havaldar in CBEC it is clarified that

the date of merger of the post of Sepoy & Havaldar in the pre-revised scale i.e. PB-1(Rs.5200-20200)with rade pay of Rs.1800/- would be effective from 29.08.08."

In view of above and on examination of the draft Seniority List of LDC in the combined limmissionerate of Kolkata- I/II/III/IV/V/VI/VII/Haldia/Bolpur/ Siliguri/ Service Tax/ Audit/ LTU and **C(P)** as on 30.04.16, 09 officers has completed 8 years of combined regular service in the grade of LDC and **Consider** as on 01.04.17 and possess the required educational qualification and are therefore found eligible **Consider** at the product of the grade of Tax Assistant.

Further, according to the Recruitment Rule of TA dated 10.01.2014 [G.S.R. 12 (E)] prescribes the formula wing eligibility under Note-1 of Column 11 :

There Juniors who have completed this qualifying or eligibility service are being considered for promotion, their there shall also be considered provided they are not short of the requisite qualifying or eligibility service by the than half of such qualifying or eligibility service or two years whichever is less and having successfully included their probation period for promotion to the next higher grade along with their juniors who have than work the such qualifying or eligibility service.' Anita Singh, LDC, Seniority list No 24 of the seniority list of LDC as on 30.04.16 has completed 08 years of combined regular service in the grade of Havaldar and LDC and satisfies the criteria of the required educational qualification and has passed the Departmental Examination and is therefore eligible for the consideration zone for promotion to the grade of Tax Assistant. In view of the above, and following the Recruitment Rule of Tax Assistants, the officers senior to her according to the Seniority list of LDC as on 30.04.16 may also be considered for promotion *provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years whichever is less and having successfully completed their probation period for promotion to the next higher grade. Shri Malaya Dutta,LDC joined in the grade of LDC on 13.02.13 and Havaldar on 23.08.11. Therefore he has rendered a combined regular service of 05 years as on 01.04.17, which is more than half of the requisite qualifying or eligibility service and he has also successfully completed the probation period for promotion period for promotion to the next higher grade. Shri Malaya Dutta,LDC joined in the grade of LDC on 13.02.13 and Havaldar on 23.08.11. Therefore he has rendered a combined regular service of 05 years as on 01.04.17, which is more than half of the requisite qualifying or eligibility service and he has also successfully completed the probation period for promotion to the next higher grade along with his juniors who have already completed such qualifying or eligibility service. Thus Shri Dutta's name has also been considered for promotion to the grade of Tax Assistant along with his juniors.*

Sanctioned Strength in the Grade of Tax Assistant is 39 in promotion quota. Working Strength is 17 in the promotion quota. Therefore there are 22 existing regular vacancies. However there are only 10 eligible officers in the consideration zone for promotion to the grade of Tax Assistant.

The DoPT's OM No.36012/17/88-Estt.(SCT) dated 25.04.89(ANNEXURE-C) states that the reservation of 15% & 7.5% for SC & ST candidates respectively is applicable to all grades or services, in which the element of direct recruit, if any, does not exceed 75%.

According to the Recruitment Rule of TA dated 10.01.2014 [G.S.R. 12 (E)](Flag-A) followed by a notification vide G.S.R.710(E) dated 15.09.15(Flag-B), 90% of the recruitment is through Staff Selection & 10% is through promotion. In view of above no reservation is required to be maintained in the promotion quota of Tax Assistant. The same has been approved by the competent authority vide NSP-27 of F.No. II(3)6-ET/CON/A-3/Kol-I/2011(ANNEXURE-D).

Regarding reservation for the persons with disability, there are one physically handicapped officer in the consideration zone who may be considered by this DPC.

Additional / Joint / Deputy Commissioner (P&V), Central Excise of the Commissionerates concerned have rendered the requisite Vigilance Clearance Certificate in respect of the Officers who are placed in the consideration zone for promotion. Moreover, records of the service of the Officers who are to be considered for promotion have been carefully scrutinized and certified by the concerned competent authority about their integrity.





View of above and on examination of the draft Seniority List of LDC in the combined commissionerate of Kolkata- I/II/III/IV/V/VI/VII/Haldia/Bolpur/ Siliguri/ Service Tax/ Mult/ LTU and CC(P) as on 30.04.16, 09 officers has completed 8 years of combined and the grade of LDC and Havaldar as on 01.04.17 and possess the required

educational qualification and are therefore found eligible for consideration of promotion to the grade of Tax Assistant.

Further, according to the Recruitment Rule of TA dated 10.01.2014 [G.S.R. 12 (E)] prescribes the following eligibility under Note-1 of Column 11 :

'Where juniors who have completed this qualifying or eligibility service are being considered for promotion, their seniors shall also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years whichever is less and having successfully completed their probation period for promotion to the next higher grade along with their juniors who have eligibility service.'

mt. Anita Singh, LDC , Seniority list No 24 of the seniority list of LDC as on 30.04.16 has completed 08 years of combined regular service in the grade of Havaldar and LDC and atlafles the criteria of the required educational qualification and has passed the Departmental Examination and is therefore eligible for the consideration zone for remotion to the grade of Tax Assistant. In view of the above, and following the ferultment Rule of Tax Assistants, the officers senior to her according to the Seniority list LDC as on 30.04.16 may also be considered for promotion provided they are not short the requisite qualifying or eligibility service by more than half of such qualifying or high billity service or two years whichever is less and having successfully completed their **Repartion** period for promotion to the next higher grade. Shri Malaya Dutta,LDC joined in rende of LDC on 13.02.13 and Havaldar on 23.08.11. Therefore he has rendered a included regular service of 05 years as on 01.04.17 , which is more than half of the fullelte qualifying or eligibility service and he has also successfully completed the abation period for promotion to the next higher grade along with his juniors who have completed such qualifying or eligibility service. Thus Shri Dutta's name has also considered for promotion to the grade of Tax Assistant along with his juniors.

Ollowing facts were placed before the Departmental Promotion Committee for Taring the Select Panel for regularization/ promotion to the Grade of Tax Mant from the feeder Grades.

Banctloned Strength in the Grade of Tax Assistant is 39 in promotion quota. Working **Grangth** is 17 in the promotion quota. Therefore there are 22 existing regular **Vacancles**. However there are only 10 eligible officers in the consideration zone for **Granot**lon to the grade of Tax Assistant.

Concling reservation for the persons with disability, there is one physically **considered** officer in the consideration zone who may be considered by this DPC.



- DoP&T's O.M. dated 10.04.89 (Flag-C) has been referred which states :

 A vacancy shall be filled in accordance with the recruitment rules in force on the date of vacancy, unless rules made subsequently have been expressly given retrospective effect."
