From the sanctioned and working strength of Tax Assistants in the Kolkata CGST & CX Zone, while sending the requisitions for SSC CGL Examination - 2020 it was observed that there were negative vacancies of 2 & 10 in the General (UR) and SC Category, respectively. On the other hand, there were 18 vacancies in the ST category and 5 vacancies in the OBC category. The total vacancies in the grade of Tax Assistant being 46, after adjustment of the negative vacancies in the General (UR) and SC categories, vacancies in the EWS category were reported as 23.
