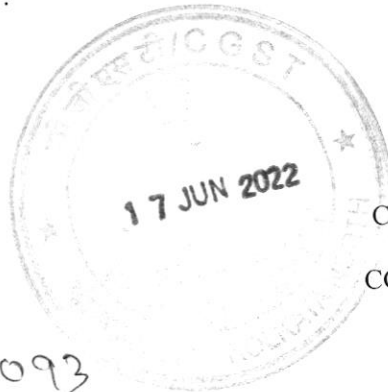

But unfortunate it is that even with the passage of around 15 years, my application has not evoked any response from the Department leave along providing me a job on the **Compassionate Ground**. I feel it quite pertinent to mention that a Unique Registration No.12 SKS 2015 has been assigned to me with the passage of long 15 years.



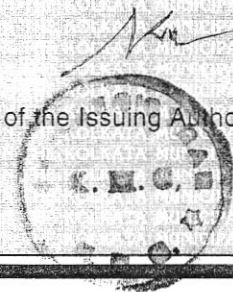
