

**Sub: Request for amendment of Form SVLDRS 2 & 3 and adjustment of pre deposit of Rs.93,042/- against tax dues of of ARN No. LD2210190000179 dated 22.10.2019.**

Kindly refer your notice issued through Form SVLDRS-2 dated 27.04.2020 for personal hearing before designated committee on 05.05.2020 at 12.30 pm at 1st Floor, 180 Shantipally Rajdanga Main Road, Kolkata - 700107.

In this connection, we submit that after the filling of SVLDRS-1 on 22.10.2019, we approached to Superintendent at Suri Range in Birbhum in the month of November 2019, we submitted the copy of pre-deposit challans and all other relevant documents and requested him to process our SVLDRS form - 1, he suggested and guided us to visit Bolpur Central Excise and GST office to pursue my request for processing Form SVLDRS-1. We visited Bolpur Central Excise and GST office in the month of November 2019 and the Asst. Commissioner at Bolpur CE & GST office informed us that my case will be processed from GST Bhawan at Kasba, Kolkata from GST central North Kolkata Range. Later we visited to above said office and met Superintendent and her colleagues and submitted all required documents along with pre-deposit challans and after verifying the documents, she told us that my case was not showing in her Online Case database GST portal for processing and she suggested to contact again Bolpur Central Excise and GST office for assignment of my case to her jurisdiction. After several efforts and follow up from all above offices, my case did not get processed from above said offices.

Due to nationwide lockdown declared by the Government of India and State of West Bengal moving out from the house was also made prohibited and punishable. In that view of the matter we could not appear before your good self office on 05.05.2020 for submission of documents.

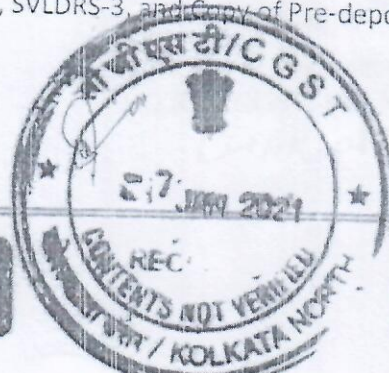
In this circumstance, we humbly request you to allow and amend our Form SVLDRS -2 & 3 and adjust pre-deposit taxes against total tax dues and permit us to make balance payment of tax dues. And we may be granted an opportunity for submission of the necessary document as required and make out our submissions.
