- 1. Name and designation of Indian Revenue Officers (IRS) who were working in Central Excise & Customs and had taken/submitted their voluntarily retirement/resignation during the period from 1<sup>st</sup> January, 2009 to 31<sup>st</sup> December, 2011.
- 2. Details of the officers against whom CBI enquiry were carried out.
- 3. Details of their property returns year wise furnished from  $\mathbf{1}^{\text{st}}$  January, 2009 to  $3\mathbf{1}^{\text{st}}$
- 4. I may be allowed to inspect their service record/files/documents and CBI enquiry report.
- 5. After inspection, I may be provided authenticated copies of the records/files/reports.
