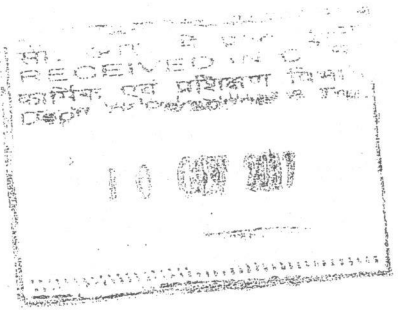

2. Details of the officers against whom CBI enquiry were carried out.
3. Details of their property returns year wise furnished from 1st January, 2009 to 31st December, 2011.
4. I may be allowed to inspect their service record/files/documents and CBI enquiry report.
5. After inspection, I may be provided authenticated copies of the records/files/reports.
