In this regard, it is intimated that under Section 29 of the CGST Act 2017 read with Rule 22 of the CGST Rules 2017, if a registered person does not file return for three consecutive tax periods or for continuous period of six months, then the said registered person is issued a notice for cancellation of registration in Form GST REG 17 requiring him to show cause within a period of seven working days from the date of service of such notice, as to why his registration should not be cancelled.

The reply to the above Show Cause Notice is given by the registered person in Form GST REG 18 within the specified period and thereafter the proper officer may cancel his registration by issuing an order in Form GST REG-19 directing him to pay any arrears of tax, interest or penalty or may drop the proceedings by passing an order in Form GST REG-20, if the reply to the said Notice is found satisfactory.

The above proceedings is being followed for non filers of GST Returns in respect of Bhowanipur Division, Kolkata South CGST & CX Commissonerate as on Jul 2019.

If you are not satisfied with the reply, you may prefer an appeal within 30 (thirty) days under section 19 of the RTI Act 2005 before Shri Pawan Kumar, 1st Appellate Authority and Joint Commissioner, CGST & CX, Kolkata South Commissionerate (3rd Floor), GST Bhawan, 180 Rajdanga Main Road, Shantipally, Kolkata 700107.
