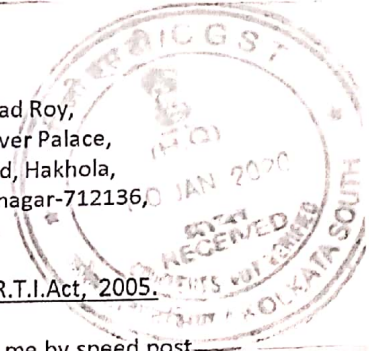

2. Please inform whether any letter/intimation received by your Comm'te from PAO or O/o. Dy.CA, EZ, Kolkata, raising objection regarding 1<sup>st</sup> MACP wrongly granted in Central Excise and ordering/advising huge recovery of lacs of rupees huge excess payment already made to above mentioned two Inspectors for last 10 years or so in spite of 1<sup>st</sup> ACP already granted to them under earlier ACP Scheme. If so, the content of the letters with date of their receipt and action, if any, taken by your Comm'te in those regards may kindly be informed.
3. Please inform whether any letter/intimation received by your Comm'te from Howrah CGST & C.Ex. Comm'te, being the Cadre Controlling Authority for Inspectors, regarding 1<sup>st</sup> MACP being wrongly granted in Central Excise in respect of the above two Inspectors, in spite of 1<sup>st</sup> ACP already granted to them earlier as they have long back issued cancellation/modification/withdrawal Orders in respect of similarly granted MACP upgradations in respect of all such Inspectors. If so, the content thereof with date of letter/intimation received and action, if any, taken by your Comm'te in those regards.
4. Please intimate amount of recovery effected in respect of the above two Inspectors for huge excess paid to them for wrong pay fixation since last 10 years or so for MACPs wrongly granted to them.
5. Please inform whether any CAT or High Court Order/interim Order was received by your Comm'te directing no recovery or no change in MACP or Pay fixation. If so, the Order issuing Authority's detail with no. and date of order.
6. If either of the above two Inspectors or both are not presently posted under Kolkata South Cpm'm'te jurisdiction, his/their present posting Comm'te with date of being relieved from Kolkata South Comm'te may kindly be furnished.
