Please refer to your RTI application dated 27.02.2020, registered at Serial No 11/RTI/S/CGST&CX/KOL/2020, addressed to the undersigned regarding supply of information under Section 6(1) of the RTI Act, 2005.

In this connection, the desired information as received from the concern authority in terms of your RTI application is as below:

- **Point No. 5(a):** There was one (1) case in Kolkata South CGST & CX Commissionerate, Investigation Report of which has been submitted by the I.O in the year 2014 or earlier and on which 2nd Stage Advice by DGV, New Delhi had already been given.
- **Point No. 5(a)(i):** Since the officer involved in the case mentioned in point 5(a) above was retired, the case is to be decided by the President under Rule 9 of CCS (Pension) Rules, 1972. Hence the Department is not the competent authority to decide the case.
- **Point No. 5(a)(ii):** NIL. The case records in respect of the disciplinary proceeding mentioned in point 5 (a) above, have already been sent to Ad-V, CBIC. However, the final decision in this case would be taken by the President and not by the Department.
- **Point No. 3(a)(iii):** Not Applicable since point 5 (a)(ii) is NIL.

If you are aggrieved by the above, you may file an appeal under Section 19(1) of the Act within thirty days of the receipt of this letter to the First Appellate Authority whose address is given below:
