

In this regard the information of just the total number of claims received by the department till date, total amount claimed & total amount of refund sanctioned by the department may please be informed.
- (b) Whether the <u>domestic turnover</u> on which the above cess has not been paid being not leviable (like say aluminium as final goods in the making of which coal, subjected to Compensation cess under the GST (Compensation to States) Act, 2017 was used as input has been considered / allowed by Department as 'exempted sales' for the purpose of arriving at the amount of 'Adjusted Total Turnover' in the computation of the refund amount stipulated under rule 89(4) of the CGST Rules.
