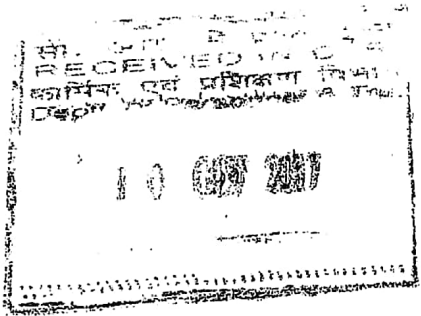
Sir,


