Sir,

I am a citizen of India.

The factual back ground being that, under DGS&D or similar Rate Contracts Purchase Orders are issued by the buying authorities much before actual supply of the goods. Estimated transport charge, as best possible to reach the actual, for required delivery of the goods at buyers' premises are necessarily to be quoted by manufacturer-supplier based on prevailing market rate at the initial stage of quotation of Tender and such estimated transport cost features in Purchase Orders as well as in CE invoices issued at the time of clearance of the requisitioned goods in terms & with reference to the Purchase Orders so issued. The said estimated transport cost under such Rate Contracts remains unchanged as the agreed amount for payment or reimbursement to manufacturer-suppliers as regards transportation concerned. Obviously and quite naturally, in some cases, difference arises between the prior estimated transport cost & actual belated delivery transport cost - especially where the span of time-gap between Purchase Orders and actual dispatches becomes wider. The difference also arises in some occasions when transport related market factors dictate a different rate at the time of actual delivery - either higher or lower - than the rate estimated at the time of quotation & issuing Purchase Orders.


