Sub: - Reply of your RTI Application dated 21.05.2019 under RTI Act, 2005 – reg.

The Point wise information related with this Commissionerate i.e. Siliguri CGST & CX Commissionerate as sought in your RTI application dated 21.05.2019; which has been received in this office on 28.05.2019 is appended below:-

- The information has been sought regarding total number of generated E-way Bill from EWB system by the purchasers of Betel Nuts of the state of North Bengal, but there is no such state named 'North Bengal'. Further, from the EWB systems, no commodity-wise report can be generated by the officers of this Commissionerate who are mapped in the EWB Systems and hence, this office is unable to provide the desired information in respect of the purchaser/traders of Betel Nuts falling within the jurisdiction of this Commissionerate.
- As regards information sought in Para (b) by the RTI applicant, this is to submit that there is no such state named 'North Bengal'. Also, regarding information pertaining to the taxpayer falling under the jurisdiction of this Commissionerate, the information cannot be retrieved from EWB systems as no commodity-wise report can be generated by the EWB-mapped officers of this Commissionerate through the E-way Bill Systems.
- Regarding information sought in Para (c), there is no such state named 'North Bengal'. Further, no such information can be retrieved from EWB systems by the mapped officers in EWB systems of this Commissionerate in respect of the purchaser of betel nuts falling under the jurisdiction of this Commissionerate; hence the information is not available with respective cell.
- There is no state named 'North Bengal'. Moreover, as no commodity-wise report is generated in the systems, hence the desired information (pertaining to the purchasers of betel nuts falling under the jurisdiction of this Commissionerate) is not available to with respective cell.
