Information Sought (जानकारी मांगी): Please refer to the letter issued vide F.No A-11019/5/2017.AD.IV dated 16.06.2017 according to which the officers are being posted on loan basis to various Directorate Generals /Directorates and their salary is being drawn from the budgetary head of the concerned CCO. However, the payment of House rent Allowance (HRA) and transport Allowance (TA) to such officers, who are posted on loan basis, are being paid out according to the whims and fancies of the administrative officer. some zones are paying HRA & TA according to the rate of their parent commissionerates whereas some zones are paying HRA & TA according to the rate of their present place of posting. Kind attention Shri B.Ginkhan Mang, Under secretary to the Govt. of India there is a need to issue clear instructions regarding the rate applicable for payment of HRA and TA to such officers who are posted on loan basis to various Directorate Generals/Directorates. Suppose a person of Jaipur Commissionerate is being transferred to Delhi Zone on loan basis or Vice-versa, kindly clarify in above two situations, what will be the applicable rates of HRA & TA to him. Your letter issued vide F.No 11019/5/2017-Ad.IV dated 06.07.2018 is not sufficient in this matter. It is pertinent to mention here that the Board vide circular F.No A-22015/117/2016-Ad.IIIA dated 20.09.2018 has directed that an Inspector transferred on Inter-Commissionerate on or after 26.12.2018 will be non-est and accordingly any officer who has joined another zone in pursuance of such order shall be on deemed loan and such Inspectors are being paid out HRA & TA according to the rate of their working place.

In view of the above facts I request every Zone of CBIC to provide the following information under RTI Act: -

1. Kindly provide the list of officers from every zone of CBIC working on loan basis in various Directorate Generals, Directorate, other Zones or to any other place.

2. Out of the above officers how many have been provided Transfer Travelling Allowance (TTA) on being transferred on loan basis

alongwith reasons and how many have not been provided TTA,
alongwith reasons of not providing the TTA.

3. Names of officers working on loan basis and are being paid out
House rent Allowance (HRA) and Transport Allowance (TA)
according to their place of posting and reasons thereof.

4. Names of officers working on loan basis and are not being paid
out House rent Allowance (HRA) and Transport Allowance (TA)
according to their place of posting and reasons thereof.

I request Cadre Controlling offices of every Zone to Compile the
information and provide as early as possible.
