Most respectfully I beg to approach to your top most sympathy for your information and to invite your attention to the following points for favour of your kind consideration:-

1. That, I beg to submit that I was suspended from service on 14.7.2005 vide C.No. II (10)A-17/VIG/CCP/WB/05/3350 Dtd:14.07.2005.
 2. That, I beg to submit that on 15.07.2005 a F.I.R was lodged at the Raiganj police Station by my the then controlling officer, Shri M.K.De, Supdt.of customs, Raiganj P.U.Uttardinaipur, W.B.
 3. That, I beg to submit that on 05.07.2006 the order of suspension revoked vide C.No.II (10)A-17/VIG/CCP/WB/05/983C Dtd:05.07.2006.At the time of my restatement vide above mentioned order ,no direction on treatment of suspension period or pay and allowances for the period was given.
 4. That, I beg to submit that the Hon'ble Commissioner of Central Excise, Haldia Commissionerate being the Disciplinary Authority passed an order on 19.02.2013 vide ORDER - IN -ORIGINAL vide C No.II (8)5/Vig/Haldia/2011/85 Dtd.19.02.2013 and a major penalty of reduction of pay was imposed on me under Rule 12 of CCS (CCA) Rules, 1965. More over, it is further stated that a disciplinary case was initiated in relation to the above referred suspension and the same was disposed off vide order dated 19.02.2013 wherein my pay was lowered by two stages but without any effect of on future increments. But this order too was silent on regularisation of the suspension period and pays and allowances for the period. Accordingly, it is regret to say that since even after 17(seventeen) years from the date of reinstatement the suspension period was not regularized and since I find that it may have affected my pay amount, I submit this representation before your good office to kindly pass a suitable order under FR-54B regarding treatment of the suspension period and all consequential.
- It is worthy to say that at that time, the said matter was under sub judice in the court of law.

4. But, this order too was silent on regularization of the suspension period and pays and allowances for the period.

Accordingly, It is regret to say that since even after 16(sixteen) years from date of reinstatement the suspension period is not regularized and since I find that it may have affected my pay amount, I submit this representation before your good office to kindly pass a suitable order under FR 54B regarding treatment of the suspension period and pay and allowances for the period from 14.7.2005 to 04.7.2006 and oblige.
