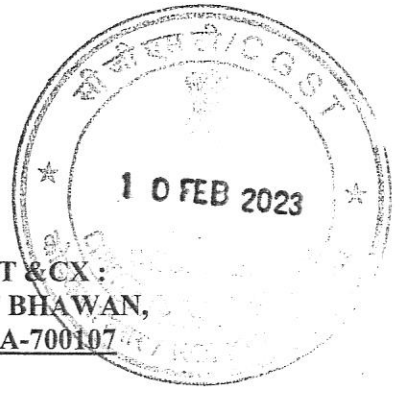

The right to information act was passed in the year 2005. It is to mention here that as per the judgment in WP (C).
