2. According to Estt. Order No. 49/2022 dated 07.06.2022 at SI. No. 239. Shri Ram Nath Prasad who was transferred from Haldia Non CCA to Appeal Kolkata – I Commissionerate, was already posted from Haldia Non CCA to DGGI, Kolkata Zonal Unit on loan basis vide Office Order No. 63/2022 dated 20.05.2022 issued by the Additional Commissioner, O/o the Principal Chief Commissioner, CGST & CX. Kolkata Zone and subsequently relieved on 27.05.2022 (A/N) from Haldia Non CCA to join his new place of posting i.e. DGGI, Kolkata Zonal Unit. Hence, his order in Estt. Order No. 49/2022 may be treated as cancelled.

- 3. According to Point No. 3 of the Estt. Order No. 49/2022 dated 07.06.2022, it was informed that 12 Superintendents, who have represented for transfer before completion of their full tenure, will not be entitled for Transfer TA. In addition to that, 03 more Superintendents (SI. No. 263, 338, 339) are also found to be not entitled for their transfer TA.
- TTA Rules should be followed strictly.
- 5. All the postings should be counted from the date of joining of the officers in the specific posting, as mentioned against his/her name, and not from the date of order.
- 6. All the officers under order of transfer should be relieved from respective Commissionerate by 18.07.2022 positively.
- 7. As a regular practice, all the Commissioners are requested to issue the rotation orders in respect of the officers posted in their Commissionerates as per the norms of rotation prescribed in the Transfer & Posting Policy published on 16.04.18 (and subsequent amendment made on 15.06.18).
- 8. Minor error / omission in the spelling of name or incorrect date of birth of any of the above officer(s), if any, should be avoided and/or corrected by the relieving authority in the relieving order taking into consideration the correspondence data of the officers available at their end.
- 9. Concerned Commissionerates / Directorates are requested to forward consolidated / compliance report (regarding relieving and joining in respect of each of the officers) by 29.07.2022, in the format as under.
