The reply to the RTI application filed by Shri Manoj Modi, 337/C, Kadam Nagar, Nr Swaminarayan Nagar, Nizampura, Vadodara, PIN 390024, Gujarat may be read as under.

- It may please be noted that this section is entrusted with issuance of Show Cause Notices and Adjudication only.
- This section is not in a position to ascertain business turnover of below Rs. 60,00,000/- of the assessee.
- This section is also not in a position to ascertain what amount had been collected by the department by way of tax, penalty and interest.
- However, as per this office available record total no. of 511 Show Cause Notices were issued for the Financial Year 2015-16 and 2016-17 under the competency of Commissioner and ADC/JC Level.
- Out of 511 Show Cause Notices mentioned above a total of 133 cases have been adjudicated.
