1. Exempted goods were brought within the CE duty net under **Sec. 11D** of the CE Act, 1944 first time with the introduction of **sub-section (1A) w.e.f. 10th May 2008**. But field formations have been demanding duty under sub-section 1(A) of Section 11D of the Central Excise Act, 1944 in respect of exempt supplies for the period prior to insertion of the said sub-section vide the Finance Act, 2008 w.e.f. 10th May, 2008.


