



Subject: Preparation of panel for appointment as Senior Intelligence Officer, Intelligence Officer, PS & Steno Gr.I on Loan/Deputation basis in the Directorate General of Goods & Service Tax Intelligence, Lucknow Zonal Unit, Lucknow and its Regional Unit located at Kanpur/Agra. - Reg.

The Directorate General of Goods & Service Tax Intelligence, Lucknow Zonal Unit. (DGGI, LZU, Lucknow) is in the process of drawing a panel of willing and suitable officers/staff for filling up the existing vacancies in Lucknow Zonal Unit including Regional Units in the grade of Senior Intelligence Officer, Intelligence Officer, PS & Steno Gr.I.

2. It is proposed to fill up the vacancies by appointing willing and suitable officers/staff on Loan/Deputation basis, for the period of two/five years as case may be from the grade of Superintendent /Inspector/ PS & Steno Gr.I. The officers, who have been granted financial up-gradation under MACP scheme, are also eligible to apply.


3. It may be made clear to the willing officers/staff that the option once given would be final and in the event of selection, he/she will not be allowed to withdraw the same.

4. It is requested that the circular may be brought to the notice of all the formations in your jurisdiction and the application of willing officers/staff be forwarded to this Zonal Unit. While forwarding the name of the willing officer/staff, the following information in respect of him/her may also be sent for evaluation by this Directorate.

- (i) Complete Bio-data and willingness of the officer.
- (ii) History of posting
- (iii) No objection certificate from Chief Commissioner's office to relieve in the event of his/her selection.
- (iv) APAR grading for the last 5 years.
- (v) Vigilance Clearance Certificate.
